COMPENSATION PACKAGE:

OIL offers one of the best pay packages in the industry. Executive Trainee will be paid a fixed stipend of Rs. 25000 pm. - Full time Post Graduate in Geophysics of 2 years duration recognised by UGC.
- Final year/semester students are also eligible to apply. However, they have to provide Bachelor's Degree/ Post Graduate Degree pass certificate at the time of interview.

PHYSICAL FITNESS:

Appointment to the above posts will be subject to the candidates being declared medically fit as per the standards prescribed for the posts by the OIL Medical Board. The provisionally selected candidates will have to undergo Pre Employment Medical Examination (PEME) conducted by the OIL Medical Board and will be finally selected to join OIL only after he/she is declared medically fit by OIL Medical Board. The decision of the OIL Medical Board will be final and binding.

SELECTION PROCESS:

- Eligible candidates will have to appear for Graduate Aptitude Test in Engineering, 2017 (GATE -2017).
- Candidates will be short listed for the next stage of selection process on the basis of GATE -2017 scores in order of merit.
- Candidates are required to qualify in GATE-2017 and thereafter in the interview separately.
- Please note that for the above ET-2017 recruitment, GATE-2017 scores will only be valid. Previous GATE scores shall not be considered.

- 01 For detailed information on GATE-2017, candidates may log on to <http://www.iitr.ac.in/gate> or on the websites of IITs(Bombay, Delhi, Guwahati, Kanpur, Kharagpur and Madras) and Indian Institute of Science (IISc), Bangalore.
- 02 The candidates, who have applied online for GATE-2017, will receive their GATE-2017 Registration Number printed on their admit card.
- 03 On receipt of GATE-2017 registration number, the candidates need to apply on-line for OIL ET-2017 on the website www.oil-india.com from Mid January 2017 to Mid February 2017.
- 04 Read the instructions carefully and fill-in the online application form giving accurate information including the GATE-2017 registration number. After successful registration, system will generate a Unique Registration Number. Candidates are required to keep the printout of the Registration slip which will be generated by the system after successful registration.
- 05 Please ensure that the GATE-2017 registration number, which is mentioned on your GATE-2017 Admit card, is filled up correctly. Name should also be filled up as appearing in GATE-2017 Admit card. No request with respect to the change in any date entered by the candidate will be entertained once the application is submitted successfully.

GENERAL INFORMATION AND INSTRUCTIONS:

1. Only Indian Nationals are eligible to apply.
2. Candidates applying for the above posts must have passed the prescribed qualifications through full time courses.
3. All qualifications should be from an Indian University / Institute recognized by AICTE/appropriate statutory authority.
4. No manual / paper application will be entertained.
5. Candidature of a registered candidate is liable to be rejected at any stage of recruitment process or after recruitment or joining, if any information provided by the candidate is false or is not found to be in conformity with eligibility criteria mentioned in the advertisement.
6. The E-mail ID entered in the online application form must remain valid for at least next one year. No change in the E-mail ID will be allowed, once entered. All future correspondence would be sent via E-mail only.
7. Candidates, if shortlisted for the next stage of selection process, are required to bring their original GATE-2017 score card at the time of interview.
8. Candidates employed with Government Departments / PSUs / Autonomous Bodies have to produce NOC at the time of interview essentially without which they would not be allowed to appear for the same.
