Expression of Interest:

Expression of Interest is requested by Oil India Limited (OIL) from subscription service provider for providing data base services on yearly subscription basis on Exploration and Production Database of petroliferous basins of the world. Data should be available in such a way that the same can be effectively utilized for evaluation of offered blocks / acreages in different bidding rounds and helps in initial risk and reward assessment of farm-in opportunities.

Scope of the Services:

Oil India Limited (OIL) is a premier Indian National Oil Company engaged in the business of exploration, development and production of crude oil and natural gas, transportation of crude oil and production of LPG. OIL also provides various E&P related services and holds 26% equity in Numaligarh Refinery Limited.

OIL has over 1 lakh sq km of PEL/ML areas for its exploration and production activities, most of it in the Indian North East, which accounts for its entire crude oil production and majority of gas production. Rajasthan is the other gas producing area of OIL.

Additionally, OIL has participating interest in NELP exploration blocks in Assam-Arakan, Mahanadi & Cauvery Offshore, Mumbai Deepwater, Krishna Godavari Deepwater, etc. as well as various overseas projects in Libya, Gabon, Iran, Nigeria, Sudan etc.

OIL is actively pursuing opportunities to acquire producing E&P assets, exploration acreages, etc. in Africa, Middle East, South East Asia, South America, CIS countries and Russia, and is willing to associate with reputed companies to jointly fulfill this objective

OIL has recently established a Centre of Excellence (CoE) at Guwahati, Assam to develop specialized and updated knowledge base and expertise for implementation of OIL's exploration, field development and production programmes through multidisciplinary studies.

One of the prime areas of interest of CoE is scenario building for acquisition of overseas exploratory and producing properties considering present and future changes in the geo-political situations covering OIL's areas of interest. Further, the CoE will work towards development of alternate and unconventional source of energy through study on various data base worldwide.
