AMENDMENT NO. 6 DATED 31.10.2018 **TO TENDER NO. SDG8304P19/07**

1.0 This Amendment No. 6 dated 31.10.2018 to Tender No. SDG8304P19/07 is issued to amend Clauses of Technical Specification, General Notes to Bidders (Annexure-I), Bid Rejection Criteria(BRC)/Bid Evaluation Criteria (BEC), extension of Bid Bond Validity (Annexure-II) to be read in place of existing; and extension of Bid Closing date, Technical Bid Opening date and Last date for Tender Fee Payment as per following details:
