Dear Sirs,

A Consortium of M/s. OIL INDIA LIMITED (OIL) & M/s. INDIAN OIL CORPORATION LIMITED (IOCL) both Government of India company, where OIL is the operator, is operating in the onshore Shakthi Block-II(G4-245), Gabon under administrative guidelines of Gabon's Direction Generale des Hydrocarbures [DGH].

1.1 Both OIL and IOCL are independent "Schedule A" premier National oil companies of India, under the Ministry of Petroleum and Natural Gas, Government of India. OIL is engaged in the business of Exploration, Production and Transportation of crude oil and natural gas and IOCL is engaged in the business of refining & transportation of crude oil and marketing of petroleum products.

1.2 In connection with its operations, OIL intends to hire a service contractor for Liaising with Government Authorities of Gabon to get Entry Permit, Work Permit, Resident Card & Labour Card for its expatriate officials.

2.0 SCOPE OF WORK:

- (i) Presently, OIL has 5 (five) expatriate officials.
- (ii) Services are required to "Liaise with Government Authorities for renewal of Resident card, Work Permit and Labor card for the existing expatriates and New Entry permit, Resident card, Work Permit and Labor card for the future incumbents as and when required."
- (iii) Contractor will apply and follow up with the Government authorities on regular basis to obtain the required Resident card / Work Permit/ Entry Permit/ Labour Card or their renewal, as the case may be, at the earliest possible.
- (iv) Contractor will deposit the application fee required to be paid to the concerned Government authority from his/their end. This amount will be reimbursed to the contractor on actual against submission of the receipt issued by the Government authority.
- (v) However, Government fee for Resident Card being very high, OIL may consider depositing the same directly to the authority. Contractor will intimate OIL about date and time well in advance and help/guide OIL to deposit the said fee.
- (vi) OIL will provide all required documents to the Contractor to apply for the permits in the office of the concerned authority.

- (vii) Once applied, the Contractor will intimate OIL the status of its progress on regular basis.
- (viii) The Contractor will quote for the service charges only excluding the applicable Government fees.
- (ix) The rates quoted should be all inclusive charges, excluding the applicable Government fees, and no extra charge will be payable. Taxes and duties shall be borne by Contractor.
- (x) The quoted rate should remain firm throughout the contract period.
- (xi) All Payments, statutory benefits and compensations to the personnel deployed for service under the contract shall be the sole responsibility of the Contractor and Company shall have no liability in this regard.

3.0 **Period of contract:** 2 (Two) years with a provision of extension up to one year more at the same rates, terms & condition at the option of company(OIL).

4.0 **Eligibility:** The bidder should be a resident of Gabon or in case of firm should be a registered in Gabon.

5.0 **Completion Time:** OIL will advise the successful bidder to arrange fresh issue or renewal of the permits, mentioned in Para 2 above, as and when required within the contractual period. Completion times of various permits are as under.

5.1 Completion time for Entry Permit, Resident Card and Labour Card is 2 (Two) months from the date of receipt of all the supporting documents, required to apply for the particular Permit, from OIL.

5.2 Completion time for Work Permit is 3 (Three) months from the date of receipt of all the supporting documents, required to apply for Work Permit, from OIL.

6.0 **Liquidated Damage (LD):** Any delay in arranging and submitting the required permit within the above specified time period, Liquidated Damage @0.5% of the contract rate for the job, per week or part thereof to a maximum ceiling of 7.5% of the contract rate for the job will be deducted from contractor's bill on each occasion of delay.

OIL may consider for extension of completion time without levying any LD amount based on the prevailing situation beyond the control of the contractor.

7.0 **TAXES:**

7.1 Being in Exploration phase, OIL is exonerated from payment of TVA.OIL shall provide Exemption Certificate for TVA against each Invoice.

7.2 All other Taxes and Levies **including withholding tax**, as applicable as per the provisions of Laws of Gabon and any other enactment/rules on income derived/payments received under the contract will be on Contractor's Account.

7.3 **Contribution Sociale de Solidarité (CSS):** CSS, if applicable shall be @1% extra.

8.0 **TERMINATION:**

Contract arising out of this tender enquiry can be terminated by the Company with 7(Seven) days notice period.

9.0 **PAYMENT:**

9.1 Payment of the Government fee will be made within 7 days of receipt of the money receipt issued by the concerned Government authority. However, Government fee for Resident Card being very high, OIL may also deposit the same directly to the authority.

9.2 Payment of the Contractor's charges will be made within 15 days of receipt of the required Entry Permit/Work Permit/Resident Card/Labour Card, as the case may be, against invoice from the Contractor.
