- B. Service Requirement : Maintenance of PCs , printers and other peripherals at PHQ, Noonmati and PS-6, Bongaigaon for a period of 2 Years.

 - (iii) The bidder should have performed PC and peripherals maintenance work for at least 50 desktop PCs with monitors, 5 Laptops and 50 Printers in a single contract.
 - (iv) Necessary documentary evidence in support of all the above eligibility criteria is to be submitted by the bidder along with the bid.
