ADDENDUM-1

IFB NO. CDI5947P21

This Addendum No. 1 dated 11.01.2021 to IFB No. CDI5947P21 for **‘Supply of Listed-III WCLs for 2D & 3D Seismic Camp Maintenance jobs in OIL’s operational areas lying North/South of River Brahmaputra in Assam & Arunachal Pradesh’** is issued to notify the following:

Point No. 3 of “Notes to BEC Clause No. 1.1” of the tender states as below:

Quote:

3) For proof of requisite experience of SIMILAR work, self-attested photocopies of following documents must be submitted along with the bid:

- I. Contract document / Work order showing details of work supported with Completion Certificate issued by PSUs / Govt. Organisation for the similar work mentioned above confirming the following:
 - a. Gross value of Similar work done
 - b. Nature of Job done.
 - c. Contract start and completion date.
 - d. Numbers of labours involved.
- II. Copy of labour license issued by the office of Labour Commissioner, State/Central Govt. for execution of the contract against Clause No. 1.1.

Note: In case of OIL’s Contractor, who had successfully completed Listed/ Unlisted (presently known as Listed-I, Listed-II & Listed-III) WCL Contracts in last 07 (Seven) years from date of bid closing are exempted to submit Experience Document in support of Clause No. 1.1. as mentioned above as well as relevant labour license issued by the office of Labour Commissioner, State/Central Govt.

They have to submit any one of the following document (self-attested copy) e.g. Work-order/SES/Completion Certificate of successfully completed Listed/Unlisted (presently known as Listed-I, Listed-II & Listed-III) WCL Contract (executed in OIL) in support of their experience criteria.

The Note (mentioned below Sl. No. II of Point No. 3 of **Notes to BEC Clause No. 1.1**) of the tender means that the contractors who have carried out or who have been carrying out the work of supply of Listed/Unlisted (presently known as Listed-I, Listed-II & Listed-III) WCL in OIL are not required to submit all the documents mentioned in Serial No. 3) I & II of “Notes to BEC Clause No. 1.1”. Instead of this, they may submit a self-attested copy of work order or SES or completion certificate

(any one) against the listed WCL contract executed / being executed by them in OIL.

However, it has come to the notice of concerned OIL officials that some bidders have misinterpreted the clause and they have presumed that they are not required to fulfil the value of work experience criteria sought in the tender and they are eligible to bid for any listed WCL tender floated by OIL irrespective of the value of work experience sought in the tender (₹1,46,95,000.00).

This addendum is issued to clarify that the contractors who have executed / have been executing Listed/ Unlisted (presently known as Listed-I, Listed-II & Listed-III) WCL supply service in OIL must also have the experience of successfully completing at least one SIMILAR work of value ₹ 1,46,95,000.00 (Rupees One Crore Four-Six Lakh Ninety-Five Thousand) in previous 07 (seven) years reckoned from the original bid closing date. They are only exempted from submission of experience documents mentioned in Sl. Nos. I & II of Point No. 3 of “Notes to BEC Clause No. 1.1, as mentioned above, i.e. instead of submitting these documents, they may submit any one of the documents work order or SES or completion certificate.

All the terms and conditions of the tender will remain the same. This addendum is issued only to clarify the Note to Point No. 3 of “Notes to BEC Clause No. 1.1”, as explained above.
