Description of Works

Improvement of existing gravel road by providing 100 mm thick WBM course & 20 mm thick premix surface including supply of all materials except bitumen & supply of all requisite plants & equipment's including Road Roller for (i) 2 km. Garden road to location TQ from Digulturrung-Baghjan road junction & (ii) 2 km. in stretches from location TP junction to location TL.

2.0 Civil Engineering Firms/ Contractors are eligible to apply against any one tender only. Company reserves the right for issuance of only one tender document to a single eligible party at Company's sole discretion.

3.0 Applicants must possess the following: -

(a) Experience of having undertaken construction of road/ road over drilling plinth with CPWD, Railways, APWD, MES, NRL, ONGCL, OIL or any other Government Organization / Public Sector Undertaking. The minimum value of contract job / jobs executed during the last 7(seven) years, ending financial year 2004-05 should be as follows:

- (i) One single contract job of value of Rs. 32.00 lakhs for tender mentioned under Para-1 (A) & Rs. 41.00 lakhs for tender mentioned under Para-1 (B), or
- (ii) Two contract jobs of value of Rs. 20.00 lakhs each for tender mentioned under Para-1 (A) & Rs. 26.00 lakhs each for tender mentioned under Para-1 (B), or
- (iii) Three contract jobs of value of Rs. 16.00 lakhs each against tender mentioned under Para-1 (A) & Rs. 20.00 lakhs each for tender mentioned under Para-1 (B).

(b) The contractor / construction firm must own in his / her / their own name / firm OR must produce an undertaking from the owners for providing services of the following minimum nos. of vehicles and equipment under good running condition, in the form of court affidavit:

- (i) Road roller of capacity 8-10 T: 2 (two) nos.
- (ii) Dumper / Truck: 1 (one) no.
- (iii) Bitumen boiler: 1 (one) no.
- (iv) Hot mix plant of 6 – 8 TPH: 1(one) no.

The documentary evidence of ownership / undertaking in the form of court affidavit of the above plants & equipment should be submitted with the application.

- (c) Average Annual Financial Turnover during the last 3(three) years, ending financial year 2005-06 should be at least Rs 13.00 lakh for tender mentioned under Para-1 (A) & Rs. 17.00 lakhs for tender mentioned under Para-1 (B). The proof of Annual Turnover should be either in the form of Audited Balance Sheet or Certification from Chartered / Cost Accountant firm indicating their membership / code number
 - (d) Documentary evidence of PF code number & PAN issued by appropriate Govt.authority.
 - (e) Documentary evidence of VAT Registration number issued by appropriate Govt. authority.
 - (f) Documentary evidence in support of sound financial standing and Bank Account No. from any Nationalized Bank.
 - (g) All the certificates and documentary evidences required to be submitted in support of para 3.0(a), 3.0(b), 3.0(c), 3.0(d),3.0(e) & 3.0(f) above should be clearly legible and duly attested by gazetted officer along with official seal. This will be applicable for all contractors / construction firms including OIL Registered contractors. **Illegible / Incomplete certificates or documents will not be considered for evaluation.**
 - (h) OIL will have the right to check the original certificates / documents at any point of time if desired and the required documents should be produced for authentication.
- 4.0 The application in sealed envelope, super scribing the Tender No. (any one) & applicant's name/ address with the details of information as mentioned above should reach the Office of HEAD (CONTRACTS), OIL INDIA LIMITED, Duliajan on or before 11:00 AM on **30.08.2006**.
