2.1 Average annual financial turnover during the least three years ending 31st March, of previous financial year should be at least **Rs. 3.77 Lakhs**.

2.2 The bidder should have experience of having successfully completed similar works during last seven (7) years ending 31 st March, 2006 with **PSUS / state / Central Govt. organizations** should be either of the following.

a) Three completed works of minimum value **Rs. 5.02 Lakhs** each.

b) Two completed works of minimum value **Rs. 6.28 Lakhs**.

c) One completed work of minimum value **Rs. 10.04 Lakhs**.

Note - Similar works means the following nature of jobs -

Possessing skilled / semiskilled man power service including deployment of equipments like welding set, cutting set, grinding machine, testing pump, pipe carrying trucks for carrying out various jobs as mentioned in the schedule of works of the tender. Civil Engg. jobs like construction of various sheds, P.C.C. & R.C.C foundation, oil / work traps, foot path etc.
