- 5.0 Bidders to note that Govt. of India under Micro, Small and Medium Enterprises Development (MSMED) Act 2006, has proclaimed the Public Procurement Policy, 2012 with effect from 1st April, 2012 in respect of procurement of goods and services, produced and provided by micro and small enterprises, by its Ministries, Departments and Public Sector Undertakings for promotion and development of Micro and Small Enterprises. A new Clause on applicability of Public Procurement Policy for procurement of goods from Micro and Small Enterprises (MSE) in the tender is furnished vide Amendment to General Terms and Conditions for Global Tender (MM/GLOBAL/E-01/2005). Bidders are requested to take note of the same and to submit their offers accordingly.
- 5.1 For availing benefits of Purchase Preference under Public Procurement Policy, the interested MSE Bidders must ensure that they are the manufacturer of tendered item(s) and registered with the appropriate authority for the said item(s). The technical offer of such MSE Bidders must include a valid copy of relevant MSE Certificate issued by appropriate authority specifying the item as per tender. Purchase Preference of 15% (fifteen percent) shall be extended to the eligible MSE Bidder (i.e. Manufacturer of tendered goods for procurement) over non-MSE L1 Bidder and PO shall be awarded for full tender quantity on such MSE bidder, subject to matching their quoted rates/costs with non-MSE L1 Bidder.
- 5.2 **MSEs Units (manufacturers/Service Providers only and not their dealers/distributors) who are already registered with District Industry Centers or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts & Handloom or any other body specified by Ministry of MSME are exempted from payment of Bid Security (EMD) irrespective of their product category & capacity, subject to submission of valid MSME registration certificate issued by appropriate authority.**
- 5.3 Micro or Small Enterprises (MSE) registered with District Industry Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of MSME shall submit copy of valid Registration Certificate for the items they intend to quote along with the bid. The Registration Certificate should clearly indicate the monetary limit, if any and the items for which bidder are registered with any of the aforesaid agencies. In case bidding MSE is owned by Schedule Caste or Schedule Tribe entrepreneur, valid documentary evidence issued by the agency who has registered the bidder as MSE owned by SC/ST entrepreneur/ Woman Entrepreneurs should also be enclosed. - 5.4 Bids without EMD shall be rejected, if the technical offer does not include a valid copy of relevant MSE Certificate issued by appropriate authority. It is in the interest of such MSE Vendors to furnish a copy of complete certificate to the concerned tender handling officer of OIL at least seven (7) days prior to the scheduled Bid Closing Date of the tender. Late communication in this regard and request for bid closing date extension on that plea shall not be entertained by Company.
- 6.0 Bidder seeking benefits of MSME and Purchase Preference Policy (Linked with Local Content) shall clearly indicate the same in the tender with proper documents as stipulated in the tender.
- 7.0 **Purchase Preference (Linked with Local Content) (PP-LC) is not applicable against this tender.**
- 8.0 OIL INDIA LIMITED (OIL) has upgraded its E-tender Portal. As part of the new system, the intending bidder must have Encryption Certificate along with Digital Signature Certificate (DSC) of Class III [Organization]. **All the Bids must be Digitally Signed using "Class III" digital certificate (e-commerce application) with 'Certificate Type: Organisation Certificate' as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India. The bid signed using other than "Class 3 with Organisation's Name" digital certificate, will be rejected.**
- 9.0 EMD must be paid either through online mode or submitted as Bank Guarantee/LC. DD/Cheques/Cashier Cheque or any other mode will not be acceptable.

9.1 OIL has made arrangement for online confirmation of Bank Guarantee through SFMS Platform with Axis Bank, Guwahati. Therefore, bidders submitting Bid Security in the form of Bank Guarantee must route the BG through SFMS platform as per following details –

- b. **The Bidder shall submit to OIL the copy of SFMS message as sent by the issuing bank branch along with the original bank guarantee.**

9.2 **Bank Guarantee issued by a Scheduled Bank in India at the request of some other Non-Scheduled Bank in India shall not be acceptable.**

12.0 Bidders are requested to examine all instructions, forms, terms and specifications in the tender. Failure to furnish all information required as per the tender or submission of offers not substantially responsive to the bid in every respect will be at the bidder’s risk and may result in rejection of its offer without seeking any clarifications.

13.0 Any deviation(s) from the tender specification should be clearly highlighted specifying justification in support of deviation.

14.0 Original Bid Closing Date shall be considered by OIL for evaluation of BRC Criteria in case of any extension of the original bid closing date.

15.0 Along with the technical bid, bidders must submit duly filled undertaking as per format provided vide **Annexure-GG** as undertaking towards submission of authentic information/documents.

16.0 The tender is invited under **SINGLE STAGE-COMPOSITE BID SYSTEM**. The bidder has to submit both the “TECHNO-COMMERCIAL UNPRICED BID” and “PRICED BID” through electronic form in the OIL’s e-Tender portal within the Bid Closing Date and Time stipulated in the e-Tender. The “Techno-commercial Unpriced Bid” shall contain all technical and commercial details except the prices which shall be kept blank. Details of prices as per Price Schedule to be uploaded as attachment in the Attachment Tab “Notes and Attachments”. Any offer not complying with above submission procedure will be rejected as per Bid Rejection Criteria mentioned in the tender.

TECHNICAL SPECIFICATION**DUCT ROUTE TRACING SYSTEM****1.0 System to be used for –**

- a. Locate & trace the route & depth of buried underground Non Metallic HDPE Pipes used in telecommunication & optical fiber cable installation.
- b. Locate blockage or collapsed point in buried non-metallic underground ducts & provide its depth.
- c. Locate & Line trace route & depth of metallic armoured OFC or telecom cables.
- d. Locate power cables.

2.0 Each system consisting of following units:**2.1 RECEIVER / LOCATOR: 1 No.**

Receiver locates the position and depth of miniature transmitter inserted in underground non-metallic HDPE Conduits and also trace underground metallic lines.

2.1.1 Specifications:

- (1) Operating Frequency: Detection of signal transmitter at minimum three frequencies including 512Hz & 16Hz. In addition, option of programming another 2(two) additional frequency by auto detection of the Transmitter.
- (2) Line trace: 8, 16, 32 & 64 kHz standard frequencies with graphic display on LED/LCD screen.
- (3) Power cable tracing (50Hz): With graphic display on LED/LCD screen.
- (4) On/Off switch with Auto shut off when not in use.
- (5) Automatic self-test of instrument at each switch on.
- (6) Audio output: Audio response during operation to be produced by an integral loudspeaker with option of headphone jack and mute switch.
- (7) Display Type: LED/LCD, Display Minimum size: 65mm x 65mm, with automatic backlight compensation.
- (8) On Screen Display: Operating mode, received signal strength, battery condition, depth measurement, signal peak locate, signal null crossing, simulated transmitter location image.
- (9) Depth measurement: Range 25 feet /7.6 meters; Push button to be provided, accurate up-to 5% for 3m depth & 10% up-to 7.6 m depth.
- (10) Target detection aids for precise detection: Handle vibration feedback, LED lights & sound feedback
- (11) Size: Portable Type.
- (12) Weight: <= 3.0 Kg (including batteries).
- (13) Power Source: Rechargeable Batteries (non-proprietary type) along with Battery Charger or AA Alkaline.
- (14) Battery Life: > 30 Hours (continuous use).
- (15) Operating temperature: 0 to 50° C.
- (16) Carrying Case: Proper carrying case / bag must be provided for the Receiver for protection and easy transportation.

2.2 TRANSMITTER: 1 No.

Miniature Sonde Transmitter for locating Pipe Route or locating blockage in non-metallic HDPE lines (minimum 33 mm diameter) / PLB Ducts.

2.2.1 Specifications:

- (1) Operating Frequency: 512 Hz.
- (2) Tone type: Continuous.
- (3) Power source: AAA 1.5V Battery or Type N.
- (4) Battery life: More than 4(Four) hours (for continuous uninterrupted use).
- (5) Should be water resistant, strong metallic body.
- (6) Size: Less than 20mm (dia.) x 80mm (length.)
- (7) Range (non-metallic): Up to 4.5m.
- (8) Suitable adopter to be provided for connection with traceable rod end.

2.3 **SIGNAL GENERATOR or LINE EXCITOR: 1 No.**

Traceable Duct Rodder Signal generator for transmitting selectable frequencies through any underground tracer wire/ metallic line / cable. Works with supplied receiver which detects frequency transmitted through the underground line.

2.3.1 **Specifications:**

- (1) Portable Type.
- (2) Weight: <=4Kg (including batteries and accessories).
- (3) Operating Frequencies: 8KHz,16KHz, 32KHz and 64 KHz selectable.
- (4) Operating Temperatures: 0 to 50 degree Celsius.
- (5) Power Supply: Standard Rechargeable Battery (non-proprietary type) along with Battery Charger.
- (6) Power output: minimum 3.5W at maximum output.
- (7) Indicators: LED or Audio - Low Battery and Ground quality.

2.4 **TRACEABLE DUCT RODDER: 1 No.**

Traceable Duct rodder with built in tracer wire for easy route tracing of underground utility and telecom pipes. Equipment is complimentary to any underground locating equipment.

2.4.1 **Specifications:**

- (1) Length of rod: 300m.
- (2) Frame: Rigid Metal frame, treated for corrosion prevention, provided with wheels and brake system.
- (3) Rod Dia: 9.0mm (nominal).
- (4) Size of built in Copper Wire 1mm Dia.

3.0 **SPECIAL TERMS AND CONDITIONS:**

- 3.1 **Warranty:** Comprehensive onsite warranty or a minimum period of 1(one) year to be provided. Warranty card to be included at the time of supply.
- 3.2 All accessories not mentioned but required for successful installation and proper working of the Duct Route Tracing system should be included in the offer.
- 3.3 Vendor should be OEM or authorised dealer (in case of dealer, Dealership Certificate to be enclosed) of the product. The OEM or authorised dealer should have properly equipped post warranty service centre in India. Service Centre list with complete address and dispatch modality for repair service to be provided in the offer.
- 3.4 **Factory pre-dispatch inspection & demonstration to be offered by vendor. All expenses on account of personnel from Oil India Limited for attending the same shall be borne by OIL.**
- 3.5 **Complete Training on field use of the Route Tracing System to be imparted for a batch of 4-5 persons at our location (site) as a condition of the offer on non-chargeable basis.**
- 3.6 The life cycle of the supplied system must be for a minimum period of 7 (seven) years from date of supply.
- 3.7 Detailed Operational and Maintenance Manual (in original) to be provided with each system, both hard copy and softcopy (DVD).
- 3.8 All batteries required to operate the system are to be included in the supply.

ANNEXURE - BB**BID EVALUATION CRITERIA (BEC)/BID REJECTION CRITERIA (BRC):****I. BID REJECTION CRITERIA (BRC):**

The bids must conform to specifications, terms and conditions given in the tender document. Bids shall be rejected in case the items offered do not conform to the required parameters stipulated in the technical specifications and to the respective national/international standards wherever stipulated. All the documents related to BRC clauses shall be submitted along with the techno-commercial Bid. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the offer/offers will be considered as non-responsive and is/are liable to be rejected, if the following conditions are not fulfilled:

(A) TECHNICAL CRITERIA:

1.0 The bidder shall be an Original Equipment Manufacturer (OEM) of the tendered item.

OR

Certified Authorised Dealer/Authorised Representative of OEM of product offered in the bid. In case bidder is a Certified Authorised Dealer/Authorised Representative, valid authorisation certificate from the OEM has to be submitted along with the bid. The authorisation certificate should have signature, email and contact number of the issuer.

2.0 IN CASE THE BIDDER IS AN ORIGINAL EQUIPMENT MANUFACTURER (OEM):

If the bidder is an OEM, then it must satisfy the following criteria and furnish the relevant documentary evidence as under along with the bid:

2.1 Bidder shall have successfully supplied at least 1(one) order for supply of 3 (Three) numbers of **similar item** in preceding 5(five) years to be reckoned from the original stipulated bid closing date of the tender to Central Government/State Government/Public Sector Unit/Private Sector Telecommunication Service Provider Limited company.

2.1.1 '**Similar item**' is defined as "**Traceable Duct Rodder System**".

2.2 The following supporting documents with respect to bidder's past supply experience as per para 2.1 above must be submitted along with the technical bid, failing which the bid shall be considered as incomplete/non-responsive -

- (i) Copy (ies) of purchase Order(s)/Contract(s) placed on the bidder by client(s).
- (ii) In addition to copies of purchase orders/contracts, any of the following document or combination of documents that substantially confirm(s) successful execution of the order(s).

The Proposal shall be examined by OIL and OIL may consider inviting a detailed offer from the Startup/MSE with the intent to place a TRIAL or TEST Order, provided the Startup/MSE meets the Quality and Technical Specifications.

In case the Startup/MSE is successful in the Trial Order, the vendor shall be considered for PQC exemption/relaxation (as the case may be) for the next tender for such item till the time it remains a Startup/MSE.
