“SELLING OF SOLID EXTRACT OF THE PROPOSED DESALINATION PLANT AT SECONDARY TANK FARM (STF), MADHUBAN, OIL INDIA LIMITED”

1. EXPRESSION OF INTEREST:

Expression of Interest is invited by Oil India Limited (OIL) from prospective in-country vendors for Selling of solid extract from the desalination plant on immediate as-is-where- is-basis from Secondary Tank Farm (STF), Madhuban of Oil India Limited located in the state of Assam.

PREAMBLE:

OIL INDIA LIMITED (OIL), a Government of India Enterprise under the Ministry of Petroleum and Natural Gas, is a premier up-stream Oil Company engaged in the business of Exploration, Production & Transportation of Crude Oil & Natural Gas as well as production of LPG, having its Headquarter at Duliajan, Assam in India.

OIL produces around 10,000 KL of crude oil per day and after dehydration, this crude oil is being transported to refineries. During the process of dehydration, substantial amount of formation water is separated out from the crude. The separated water is further treated in Effluent Treatment Plant (ETP) to maintain the required parameter for underground disposal.

However, this treated water is not suitable for reuse in plants due to the presence of dissolved salt. OIL is now planning to remove the dissolved salt through a desalination plant so that this water can be reused. On the process of desalination, it is expected that a considerable amount of salt (mainly Halite) will be generated approx. 750 Kg per day.

OIL INDIA LIMITED (OIL) intends to explore the possible vendors/party who may like to **BUY** the solid extract of the desalination plant for their utility on mutual agreeable terms and conditions.

2. LOCATION OF THE AREA:

The STF-Madhuban plant where the desalination plant will be established is located at a distance of around 47 Km from Dibrugarh town in Assam. It is located at around 6 Km from Duliajan.

3. SCOPE OF WORK:

Scope of work under this EOI encompasses the following jobs (but not limited to):

- a) Collection of solid (mostly halite), that would be generated from the proposed desalination plant at STF-Madhuban (approx. 750 Kg per day).
- b) Packaging to be done with suitable bags for transportation to avoid spillage by the firm/vendor on their own cost.
- c) Manpower for the job is to be provided by the firm/vendor.
- d) Transportation of the solid extract from OIL's custody transfer point (i.e. STF-Madhuban) to the firm/vendor plant/ warehouse is to be arranged by the vendor at their own cost.
- e) Weighing the salt shall be done at the STF-Madhuban by the firm/ vendor. OIL will provide suitable site at STF Plant for packaging/handling of the solid. Weighing machine for weight measurement shall be within the scope of the firm/vendor.
- f) The firm/vendor shall submit an end-use certificate of the solid extract utilized to OIL.

4. DETAILED ANALYSIS OF SOLID EXTRACT

Detail analysis of the solid extract of desalination plant (generated at the pilot trial of desalination plant at STF-Madhuban) is as follows:
