Preamble:

A GeM Tender was floated for Integrated Facility Management Services including Mechanized/manual Housekeeping, Catering, Office Assistance, Waste Management, Horticulture, Pest Control Service, Front Office Management, Façade/Exterior cleaning of multi-storeyed buildings vide tender no: GEM/2025/B/6320818 dated 07.06.2025.

As a part of the tendering process, a Pre-Bid Conference was scheduled on 18.06.2025 at Guwahati to address any queries from the prospective bidders. A GeM notification was issued regarding submission of queries beforehand via Email so that the queries can be addressed in the Pre-Bid Conference. Accordingly, a few queries were received via email which were addressed during the Pre-Bid Conference. Moreover, a few queries were also

raised during the Conference itself and the same were also addressed. Details of deliberations are as below:

1.0 M/s. Refma Facility & Hospitality (I) Pvt. Ltd : (Physically Present)

The rate will be fixed considering the prevailing market rate of raw materials, rate chart of various items of nearby hotels and standard rate of out Guest House and other running contract agreement wherein catering services are included.
