1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

7) **Special Terms and Conditions:**

7.1 Warranty period of the supplied products shall be minimum of 1(ONE) year from the date of final acceptance of goods or after completion of installation, commissioning and in-house testing of goods, whichever is earlier.

7.2 Supply: The bidder has to provide a sample of the Rectangular Adjacent side of leg Classroom Table within 60 days after receipt of the Purchase Order. 7.4 The supplied item(s) should be brand new, unused and of prime quality. The items shall be procured from the Original Equipment Manufacturer (OEM) or from their authorized dealers only. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-
