OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. 3) **Payment Timelines**: Payments shall be made to the Seller within 21 days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills (This is in supersession of 10 days' time as provided in clause 12 of GeM GTC).

8) **Scope of Installation and Commissioning of Split Air Conditioners:**

(i) The supplier shall depute competent and qualified personnel for installation and commissioning of the air conditioners strictly in accordance with the manufacturer's recommendations and standard practices.
