OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. 2) Financial Criteria Exemption for MSE Manufacturers:

Micro and Small Enterprises (MSEs) participating as manufacturers of the quoted products shall be exempted from meeting the financial criteria specified in this tender.

1.This exemption shall not apply to entities participating as Traders, Distributors, Sole Agents, or Works Contractors.

2. Bidders claiming exemption under this clause must submit valid supporting documents along with their bid to establish their status as MSE manufacturers.

6) The same or similar category of products as mentioned in experience criteria means "2.0 Ton (Standard Cooling at full capacity not less than 6200 Watt) 5 Star Split Air Conditioners Only".
