1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

(ii) MSE Vendor hereby agrees to indemnify, hold harmless and keep OIL and its affiliates, Directors, officers, representatives, agents and employees indemnified, from any and all damages, losses, claims and liabilities (including legal costs) which may arise from Seller's submission, posting or display, participation, in any manner, on the TReDS Platform or from the use of Services or from the Buyer's breach of any of the terms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity basis.

(iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any damages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from using TReDS platform for discounting their (MSE Vendor's) invoices.

2.0 "FORWARDING LETTER & INSTRUCTION TO BIDDERS", "GENERAL CONDITIONS OF CONTRACT", "SPECIAL CONDITIONS OF CONTRACT", "ALL ANNEXURES & PROFORMAS", "BEC/BRC", etc., attached in "Buyer Added Bid Specific ATC" tab. Bidders shall have to upload duly filled-up Annexures and Proformas along with documentary evidence in support of the evaluation criteria and item specifications as per the tender, along with the technical bid.

3.0 If any of the specifications/ clauses mentioned in the body of the tender document contradict those mentioned in the document uploaded under "Buyer added bid specific ATC", the specifications/ clauses mentioned in "Buyer added bid specific ATC" shall prevail.

4.0 Bidders are advised to submit their queries, if any, within 15 days from the date of tender publication. OIL shall not be liable to respond to any queries received after the stipulated deadline.

5.0 The items covered in this Tender shall be used by Oil India Limited in the Petroleum Exploration License (PEL) and Mining Lease (ML) areas, and hence concessional GST @12% will be applicable as per the Government. Policy in vogue.

Note: Successful bidder shall arrange to provide all necessary documents (invoice, etc.) to OIL for applying the essentiality Certificate on receipt of request from OIL or at least 45 days prior to their readiness for despatch, whichever is earlier. Further, the successful bidder shall affect dispatch only on receipt of relevant certificates/shipment clearance from OIL, failing which all related liabilities shall be to the supplier's account.

6.0 The bidder shall provide technical literature/ catalogue along with the offer for technical scrutiny, failing which the offer will be liable for rejection.

7.0 The item shall be procured from the original equipment manufacturer or their authorized dealers/agents. In case of a dealer/agent, the party must submit a copy of their valid authorization certificate from OEM, without which the offer shall be liable for rejection.

8.0 All types and sizes of cables being supplied shall be subjected to Type tests, Routine tests, and Acceptance tests according to relevant standards. The bidder shall provide relevant test certificates along with the items supplied. A sample test certificate shall be provided along with the offer, failing which the offer will be liable for rejection.

9.0 The item shall be guaranteed for a minimum period of 12(twelve) months from the date of commissioning or 18(eighteen) months from the date of receiving at the Instrumentation Deptt. whichever is earlier.

10.0 Cables shall comply with the latest edition of the following standards prior to the date of the purchaser's enquiry.
