Oil India Limited has adopted Purchase Preference policy linked with Local Content issued by MOPNG vide notification no. FP-20013/2/2017-FP-PNG dated 17.11.2020 and the original policy was approved by the Cabinet. This policy is applicable for tender value more than Rs. 1 Crore to treat the local supplier as Class I, Class II and Non Local Supplier and to extend the benefit of purchase preference accordingly as per policy. Since, the estimated value of the subject tender is less than Rs. 1 Crore, no Purchase Preference Policy shall be applicable against this tender.

Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1.0 Financing of trade receivables of Micro and Small Enterprises (MSEs) through the Trade Receivables Discounting System (TReDS) platform.

Based on the initiatives of the Government of India to help MSE vendors get immediate access to liquid funds based on buyers' credit ratings by discounting, OIL has registered itself on the TReDS platform with M/s. RXII and M/s. A TREDS Ltd. (Invoice Mart). MSE vendors can avail themselves of this benefit by registering themselves with any of the exchanges providing e-discounting/electronic factoring services on the TReDS platform and following the procedures defined therein, provided OIL is also participating in such a TReDS platform as a buyer.

(i) The vendor should be aware that all costs relating to availing the facility of discounting on the TReDS platform, including but not limited to registration charges, transaction charges for financing, discounting charges, interest on financing, or any other charges known by any name, shall be borne by the MSE vendor.

(ii) MSE Vendor hereby agrees to indemnify, hold harmless, and keep OIL and its affiliates, directors, officers, representatives, agents, and employees indemnified from any and all damages, losses, claims, and liabilities (including legal costs) that may arise from Seller's submission, posting, or display; participation in any manner on the TReDS Platform; the use of Services; or the Buyer's breach of any of the terms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity basis.

(iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any damages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, or loss of information), whether in contract, tort, equity, or otherwise, or any other damages resulting from using the TReDS platform for discounting their (MSE Vendor's) invoices.

Note:

(i) Buyer means OIL, who has placed a purchase order/contract with an MSE vendor (seller).

(ii) Seller means an MSE vendor who has been awarded a purchase order/contract by OIL (buyer).

2.0 "Statement of Non-Compliance (Annexure-AA)," "Commercial Check List (Annexure-BB)," and "Undertaking of authenticity of information/documents submitted (Annexure-K)" are attached in the "Buyer Added Specific ATC" tab. The bidder shall have to upload the duly filled-out annexures with a seal and sign along with the technical bid.

3.0 If any of the specifications/clauses mentioned in the body of the tender document contradict those mentioned in the document uploaded under "Buyer added bid specific ATC," the specifications/clauses mentioned in "Buyer added bid specific ATC" shall prevail.

4.0 Bidders are advised to submit their queries, if any, within 15 days from the date of tender publication. OIL shall not be liable to respond to any queries received after the stipulated deadline.

5.0 A Guarantee/Warranty certificate for 18 months from the date of despatch or 12 months from the date of receipt, whichever is earlier, will be required along with the supply.

6.0 Bidder to approve the final Drawing from the user department before fabrication jobs.

7.0 The items covered in this Tender shall be used by Oil India Limited in the Petroleum Exploration License (PEL) and Mining Lease (ML) areas, and hence concessional GST @12% will be applicable as per the Government Policy in vogue.

Note: Successful bidder shall arrange to provide all necessary documents (invoice, etc.) to OIL for applying essentiality Certificate on receipt of request from OIL or at least 45 days prior to their re-

diness for despatch, whichever is earlier. Further, the successful bidder shall affect dispatch only on receipt of relevant certificates/shipment clearance from OIL, failing which all related liabilities shall be to the supplier's account.

7. Generic

The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
