1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

6. **Warranty**

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. 2.0 Special Terms and Conditions of the Tender are also attached in Annexure -A. Bidder are requested to provide their compliance in their offer against the same.

2.1 Packaging of the items shall be adequate enough to avoid any transit damage and water ingress.

2.2 Warranty: The item shall be warranted for a period of minimum 12 months from the date of receipt at Electrical Engineering Department, Duliajan.

2.3 All the items supplied shall be new and of latest make.

2.4 The following test certificates/ reports shall mandatorily be submitted along with the bid:

a. Test reports/certificates confirming to LM 79 from an Indian government laboratory or NABL accredited laboratory or IEC accredited laboratory shall be submitted. Additionally, LM 80 test reports/certificates shall be submitted from the OEM of the LED chip.

b. Photo biological safety test reports/certificates confirming to IS16108:2012 or IEC/EN 62471 shall be submitted.

c. Explosion proof test report/certificate as per IS/IEC 60079 standard (Ex-d) from Indian Govt. Laboratory or NABL accredited Laboratory or IECEx accredited Laboratory or ATEX notified body, which is not a part of manufacturer.

2.5 Bidder shall mention the make and model of the item offered and submit technical datasheet/ literature/catalogue of the offered item along with the bid.

2.6 The items will be used for Hazardous Area Zone-1 and 2, Gas Group IIA & IIB, complete with all accessories and Ex-d certified as per IS/IEC 60079-1:2007 standards.

2.7 Materials shall be procured either from manufacturer or their authorised dealers/channel partners only. In case of authorised dealers or channel partners, they must submit valid dealership certificate along with the offer.

4.0 Avoidance of Extension for Bid Submission clause-

Bidders are earnestly advised to ensure that their bid submissions are prepared and submitted in accordance with the deadlines specified in this tender document. OIL has taken all necessary steps to establish reasonable timelines for the submission of bids to allow ample time for thorough preparation. As a matter of policy, OIL will only consider granting an extension of the bid submission due date as a one time exception in situations deemed unavoidable. Such extensions will be granted solely at the discretion of OIL and only in response to a written request from the bidder (mail to sukanya_buragohain@oilindia.in), submitted in accordance with the procedures outlined in this tender document. It is hereby emphasized that OIL will not entertain or consider any requests for an extension of the bid submission due date, except in cases where OIL deems such extension unavoidable necessitating the extension. Bidders are therefore strongly advised to refrain from seeking an extension of the bid submission due date unless absolutely necessary due to unforeseen and unavoidable circumstances.
