Oil India Limited has adopted Purchase Preference policy linked with Local Content issued by MOPNG vide notification no. FP-20013/2/2017-FP-PNG dated 17.11.2020 and the original policy was approved by the Cabinet. This policy is applicable for tender value more than Rs. 1 Crore to treat the local supplier as Class I, Class II and Non Local Supplier and to extend the benefit of purchase preference accordingly as per policy. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Buyer Added Bid Specific ATC

1.0 Financing of trade receivables of Micro and Small Enterprises (MSEs) through TradeReceivables Discounting System (TReDS) platform. Based on the initiatives of Government of India to help MSE vendors get immediate access to liquid fund based on Buyers credit rating by discounting, OIL has registered itself on TReDS platform with M/s. RXII, and M/s. A TReDS Ltd. (Invoice Mart). MSE vendors can avail this benefit by registering themselves with any of the exchanges providing e-discounting / electronic factoring services on TReDS platform and following the procedures defined therein, provided OIL is also participating in such TReDS Platform as a Buyer.

(i) Vendor should be aware that all costs relating to availing the facility of discounting on TReDS platform including but not limited to Registration charges, Transaction charges for financing, Discounting Charges, Interest on financing, or any other charges known by any name shall be borne by MSE Vendor.

(ii) MSE Vendor hereby agrees to indemnify, hold harmless and keep OIL and its affiliates, Directors, officers, representatives, agents and employees indemnified, from any and all damages, losses, claims and liabilities (including legal costs) which may arise from Sellers submission, posting or display, participation, in any manner, on the TReDS Platform or from the use of Services or from the Buyer's breach of any of the terms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity basis.

(iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any damages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from using TReDS platform for discounting their (MSE Vendor's) invoices.

Note:

(ii) Seller means a MSE vendor, who has been awarded Purchase Order / Contract by OIL, (Buyer).

2.0 "FORWARDING LETTER & INSTRUCTION TO BIDDERS", "GENERAL CONDITIONS OF CONTRACT", "SPECIAL CONDITIONS OF CONTRACT", "ALL ANNEXURES & PROFORMAS", etc. attached in "Buyer Added Bid Specific ATC" tab. Bidders shall have to upload duly filled up Annexures and Proformas along with documentary evidence in support of evaluation criteria and item specifications as per tender along with the technical bid.

3.0 If any of the specifications/ clauses mentioned in the body of the tender document contradict with that mentioned in the document uploaded under "Buyer added bid specific ATC", the specifications/ clauses mentioned in "Buyer added bid specific ATC" shall prevail.

4.0 Bidders are advised to submit their queries, if any, within 15 days from the date of tender publication. OIL shall not be liable to respond to any queries received after the stipulated deadline.

5.0 The offered product shall be of current versions with latest technology and should comply with the specifications mentioned in the tender. The manufacturer shall have adequate after sales service in India & be able to provide technical backup services. Details of servicing center in India to be submitted along with the bid.

6.0 Bidder must submit Data sheet/ Product Brochure for the item along with the bid. Incomplete offer will be liable for rejection.

7.0 Bidder may visit the site before quoting with due permission of OIL authorities of Kolkata Office.

8.0 Bidder/OEM must have an office/service centre in West Bengal to provide necessary support during the warranty period. The details of the same must be submitted along with bid documents.

9.0 Bidder must submit sample pictures of the proposed Model along with the bid.

10.0 Warranty period of the supplied products shall be 1 year from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods whichever is later. Timely Servicing / rectification of defects to be done by the supplier during warranty period.

11.0 Payment terms: 100% payment will be made within 21 days after receipt and successful installation and commissioning of the elevator at site against undisputed invoice.

12.0 Delivery to be done at Diroi Guest House, 2E, Charu Chandra Avenue, Tollygunge, Kolkata-700033. The item should come with proper packing to avoid transit damage.

13.0 Installation time: **60 days** for delivery of materials from date of issue of purchase order. Complete installation, testing & commissioning are to be done within **30 days** after delivery of the item.

14.0 Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 100 % of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
