1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

Special Terms and Conditions:

1. The supplied item(s) should be brand new, unused and of prime quality. The items shall be procured from Original Equipment Manufacturer (OEM) or from their authorized dealers/ agents only. In case bidder is not OEM of the offered product, a valid dealership certificate / authorisation certificate from OEM must be enclosed along with the offer.
2. The supplied products should be guaranteed against manufacturing defects and quality of material. Warranty/Guarantee period of the supplied products should be atleast 1 year from the date of final acceptance of goods at consignee location. Duly signed and stamped OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods.
3. Responsibility for replacement of either defective or dissimilar materials of order is under the scope of the Supplier (OEM/ OEM authorized dealer). If such a case arises, the supply shall be considered complete only after rectification/replacement of the damaged/defective material up to the satisfaction of M/s OIL.
4. Packing of the materials should be adequate to avoid ingress of water/moisture and to safeguard the items from damage during transit. If any damage is found at the time of receipt of the materials, they must be replaced by the supplier with new item at their own cost.
5. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
6. The Bidder/OEM must have office/service centre in Assam to provide necessary support during warranty period. The details of the same must be submitted along with bid documents.
7. Detailed catalogue mentioning the model offered to be submitted along with the quotation without which the offer will be rejected.
8. Item(s) shall be supplied in assembled condition. In case of supply of the item(s) is/are in dismantled condition, the supplier shall have to assemble the items at the respective user department of Oil India Limited, Duliajan within 15 days time from the date of delivery without any extra cost to OIL

9. Queries Submission Timeline clause:

All prospective bidders are hereby instructed to submit any queries or requests for clarification related to this tender within a period of five (5) calendar days from the date of publishing of this tender document. Any queries received after the stipulated deadline will not be entertained or responded to by OIL. Queries must be submitted in writing via email to Stuty.Khound@oilindia.in. 10. Avoidance of Extension for Bid Submission clause:

Bidders are earnestly advised to ensure that their bid submissions are prepared and submitted in accordance with the deadlines specified in this tender document. OIL has taken all necessary steps to establish reasonable timelines for the submission of bids to allow ample time for thorough preparation. As a matter of policy, OIL will only consider granting an extension of the bid submission due date as a one time exception in situations deemed unavoidable. Such extensions will be granted solely at the discretion of OIL and only in response to a written request from the bidder (mail to Stuty.Khound@oilindia.in), submitted in accordance

ce with the procedures outlined in this tender document. It is hereby emphasized that OIL will not entertain or consider any requests for an extension of the bid submission due date, except in cases where OIL deems such extension unavoidable and the bidder submits a formal written request, detailing the compelling circumstances necessitating the extension. Bidders are therefore strongly advised to refrain from seeking an extension of the bid submission due date unless absolutely necessary due to unforeseen and unavoidable circumstances. By participating in this tender process, all bidders acknowledge and accept the terms and conditions outlined in this Avoidance of Bid Submission Due Date Extensions clause.
