1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1.0 Financing of trade receivables of MSEs through TReDS platform:

Based on the initiatives of Government of India to help MSE vendors get immediate access to liquid fund based on Buyers credit rating by discounting, OIL has registered itself on TReDS platform with M/s RXII, and M/s A TReDS Ltd. (Invoice Mart). MSE vendors can avail this benefit by registering themselves with any of the exchanges providing e-discounting / electronic factoring services on TReDS platform and following the procedures defined therein, provided OIL is also participating in such TReDS Platform as a Buyer.

(i) Vendor should be aware that all costs relating to availing the facility of discounting on TReDS platform including but not limited to Registration charges, Transaction charges for financing, Discounting Charges, Interest on financing, or any other charges known by any name shall be borne by MSF Vendor.

(ii) MSE Vendor hereby agrees to indemnify, hold harmless and keep OIL and its affiliates, Directors, officers, representatives, agents and employees indemnified, from any and all damages, losses, claims and liabilities (including legal costs) which may arise from Sellers submission, posting or display, participation, in any manner, on the TReDS Platform or from the use of Services or from the Buyer's breach of any of the terms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity basis.

(iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any damages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from using TReDS platform for discounting their (MSE Vendor's) invoices.

Note:

(1) Buyer means OIL, who has placed Purchase Order / Contract on a MSE Vendor (Seller).

(2) Seller means a MSE vendor, who has been awarded Purchase Order / Contract by OIL, (Buyer).

2.0 "Statement of Non-Compliance (Annexure-AA)", "Commercial Check List (Annexure-BB)", "Undertaking of authenticity of information/documents submitted (Annexure-K)" attached in "Buyer Added Specific ATC" tab. Bidder shall have to be upload the duly filled up Annexures with seal and sign along with the technical bid.

3.0 If any of the specifications/ clauses mentioned in the body of the tender document contradict with that mentioned in the document uploaded under "Buyer added bid specific ATC", the specifications/ clauses mentioned in "Buyer added bid specific ATC" shall prevail.

4.0 Bidders are advised to submit their queries, if any, within 15 days from the date of tender publication. OIL shall not be liable to respond to any queries received after the stipulated deadline.

5.0 Documents to be submitted for Fire Detection & Alarm System at Brooklyn Godown, Kolkata along with the bid:

a) The bidder shall submit the technical catalogue/manuals of the offered Fire Alarm Control Panel (FACP), Multi-sensor detector, Beam detector, Manual Call Point, Sounder with Strobe.

b) Fire Alarm Control Panel (FACP), Multi-sensor detector, Beam detector, Manual Call Point, Sounder with Strobe shall have UL/FM/VdS/ EN54/ IS certification. The bidder has to submit the certification / listing documents at the time of bidding.

c) The bidders must submit a written undertaking that they would be able to supply all the requisite spares for a minimum period of 10 (ten) years from the date of completion of the smoke & fire detection systems.

6.0 In the event of an order, successful bidder will have to provide the following documents along with the supply for Fire Detection & Alarm System:

a) 2 (two) sets of Operation & Maintenance manual of the complete system shall be supplied in Hard copy & Pen drive with delivery of the items.

(b) 2 (two) sets of Layout drawing of the Smoke & Fire Detection systems showing all the components such as detectors, strobe, MCP shall be supplied after completion of the installation & commissioning. (In both Hard copy & Soft Copy)

7.0 For supply and installation of the Fire Detection & Alarm System, the bidder may take up the site survey activity before submitting the tender for getting acquainted with system requirements & environment.

7.1 Installation & Commissioning for Fire Detection & Alarm System at Brooklyn Godown, Kolkata:

Following functional tests shall be carried out as a part of system acceptance test during the installation and commissioning at site:

(a) Hardware verification as per final bill of material.

(b) Visual and mechanical check-up for proper workmanship, identification, ferruling, name plates etc.

(c) Demonstration of all system diagnostics.

(d) Checking of proper functioning of FACP, detectors, strobe, alarms etc.

(e) After successful Installation & Commissioning, the complete system shall be put under observation for 72 continuous hours for each of Smoke & Fire Detection panel. During this period, any malfunctioning of the system components shall be replaced/repared as required free of cost (under bidder's scope).

7.2 Training at Site:

Successful Bidder shall impart training to OIL's site personnel for routine operation & preventive maintenance of the Fire Detection and Alarm System. The training shall be imparted for minimum 1 (one) day immediately after successful acceptance of the complete system at that building.

(a) Training on the operation of the entire systems as per functional requirement including start up and shut down of the system.

(b) Maintenance training on the hardware being supplied.

(c) Calibration/maintenance aspect of the field detectors.

(d) Cost towards such training/demonstration is inclusive in the installation/commissioning charges.

7.3 Warranty for Fire Detection and Alarm System:

(a) The equipment/materials will be guaranteed for a period of 18 (eighteen) months from the date of receipt of the material at OIL's depot or 12 (twelve) months from the date of com

commissioning whichever is earlier.

(b) To keep the system fully operational, in case of failure of any item during the warranty period, it shall be the successful bidder/supplier's responsibility to arrange replacement/repairing at site at their cost including customs, freight, etc. within a period of maximum 2 (two) weeks from the date of intimation of such failure. However, if party do not attend the fault, repair/replace the faulty system within stipulated period, warranty of the entire system of that particular building will be restart from the date of making the system operational.

8.0 Documents to be submitted for 4.5kg CO2 Fire Extinguisher along with the bid:

The bidder shall submit the technical catalogue/manual of the offered Fire Extinguisher.

9.0 In the event of an order, the following test report to be submitted along with the supply of extinguishers:

- a) Performance Test: 01 no.
- b) Hydrostatic Test: 100% of the Ordered Quantity
- c) Other tests as applicable as per IS-15683 (latest)
- d) BIS certificate for extinguishers (The same to be submitted at the bid also)
- e) PESO Certificates for cylinders & Valves
- f) Hydrostatic Test Reports
- g) Lab test report of materials of constructions (MOC) and other tests reports
- h) Standard Operating Procedure (SOP)
- i) Warranty Certificates
- j) Purity Certificate of the extinguishing media (CO2)

9.1 Warranty: The minimum warranty of 12 (Twelve) months from the date of successful commissioning of the units or 18 (Eighteen) months from the date of dispatch of the units, whichever is earlier.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of

Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
