Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

1) **Queries Submission Timeline clause-**

All prospective bidders are hereby instructed to submit any queries or requests for clarification related to this tender within a period of five (5) calendar days from the date of publishing of this tender document. Any queries received after the stipulated deadline will not be entertained or responded to by OIL.

Queries must be submitted in writing via email to Swarup_majumder@oilindia.in. Please ensure that the subject line of your email clearly states "Tender Query & GEM Bid No.".

2) **Payment Timelines:** Payments shall be made to the Seller within 21 days of issue of consignee receipt -cum-acceptance certificate (CRAC) and on-line submission of bills (This is in supersession of 10 days' time as provided in clause 12 of GeM GTC).

3) The bidders **are not required to submit EMD** against this GEM Bid.

4) Bidders are requested to submit all the Proformas as per the requirement of the GEM bid.

5) PBG should be valid for 21 months from the date of issue. PBG validity less than the above-mentioned period will have to be amended by the seller.

6) **INSTALLATION AND COMMISSIONING:**

Installation and commissioning of the complete unit shall be carried out by the supplier at site in Duliajan Assam on the Truck Mounted Mobile Steam Generator Unit. The supplier shall depute their representative/ service engineer to Duliajan, Assam within 1 Month after receipt of material at site. The entire installation of the commissioning of the unit to be completed within 1 Month for each unit.

The offered Unit should not exceed 850 mm (3 ft) (L) X 850 mm (3 ft) (B) X 1100 mm (4 ft) (H).

Lodging/Boarding & transportation of bidder/supplier's personnel shall be in the scope of bidder.

7) **SCOPE OF SUPPLY:**

1. Stainless Steel Filter Vessel 178 mm OD X 650 mm overall length with Good Manufacturing Practice (GMP) standard – 1 no.
2. Feed pump (for safe area operations) giving minimum 2 kg/cm².g pressure connected to 0.25 KW motor maximum.
3. Total Hardness Reduction Filter Element Set of 6 nos. – 1 set.
4. Interconnecting hoses and hose fittings – 1 lot
5. Isolation and bypass valve (1" Ball valve) – 5 nos.
6. Skid Base with drains and plugs – 1 set.
7. Pressure Gauge with needle isolation valve: 2 nos.
8. Vent and drain valves: 1 set.
9. One Set of Shapes of Spare Cartridges & Seal kit.

Overall Dimensions with installed Cartridges: 850 mm (3 ft) (L) X 850 mm (3 ft) (B) X 1100 mm (4 ft) (H) max. It should not exceed these dimensions.

Note: The above skid will have an average capacity of water purification for 30000-31500 litres before change of filter cartridge set. The filter is specially designed for removal of hardness and scale forming impurities from water. After changeout, each set of filter will provide 30,000 litres of purified water consistently. Filter changeout needs maximum 15 min.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
