Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Buyer Added Bid Specific ATC

### 1) **Queries Submission Timeline clause-**

All prospective bidders are hereby instructed to submit any queries or requests for clarification related to this tender within a period of five (5) calendar days from the date of publishing of this tender document. Any queries received after the stipulated deadline will not be entertained or responded to by OIL.

Queries must be submitted in writing via email to Swarup\_majumder@oilindia.in. Please ensure that the subject line of your email clearly states "Tender Query & GEM Bid No."

2) **Payment Timelines:** Payments shall be made to the Seller within 21 days of issue of consignee receipt -cum-acceptance certificate (CRAC) and on-line submission of bills (This is in supersession of 10 days' time as provided in clause 12 of GeM GTC).

3) The bidders **are not required to submit EMD** against this GEM Bid.

4) Bidders are requested to submit all the Proformas as per the requirement of the GEM bid.

5) Packaging of the items shall be adequate enough to avoid any transit damage.

6) The bidder shall mention make and model of the product offered.

7) All the items supplied shall be new and of latest make.

8) Test reports/certificates:

i) Plug and receptacle shall be of flameproof (Ex-d) type, suitable for use in oilfield hazardous area, Zone-I of Oil Mines, and gas group IIA & II B of oil mines and shall conform to IS/IEC/EN:60079-0 and IS/IEC/EN:60079-1. (As per Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2022, Regulation no. 112).

ii) Test reports conforming to the above from an Indian Government Laboratory or NABL accredited laboratory or IEC-Ex accredited laboratory or ATEX notified body, which is not a part of manufacturer's facility, shall be submitted with the bid as well as with the supply of materials.

9) Warranty: The item shall be warranted for a period of 12 months from the date of receipt at Electrical Engineering Department, Duliajan.
