1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 2. 1) **Queries Submission Timeline clause-**

2) **Payment Timelines:** Payments shall be made to the Seller within 21 days of issue of consignee receipt -cum-acceptance certificate (CRAC) and on-line submission of bills (This is in supersession of 10 days' time as provided in clause 12 of GeM GTC).

3) The bidders **are not required to submit EMD** against this GEM Bid. However, **Bid Security Declaration is applicable in this tender**. Bidders are requested to Submit the same in **Proforma-O** attached herewith.

4) Bidders are requested to submit all the Proformas as per the requirement of the GEM bid.

5) The same or similar category of products as mentioned in experience criteria means "supply installation and commissioning of Bypass conductors at Floating Roof Tanks storing crude oil/petroleum products. The work experience shall consist of both supply and I&C. Work experience with only supply of material will not be acceptable".

6) Items shall be procured from OEM or their authorized dealer only. Bidders other than OEM shall have to submit valid authorization certificate or dealership certificate.

7) Items should be delivered within 6 weeks from the date of issue of GEM Contract.

8) Bidder should categorically confirm compliance to the Technical Specifications as mentioned in the tender.

9) **Pre-dispatch inspection is applicable. Also, the supplier will intimate OIL at least 15 (days) a head of pre-dispatch inspection informing readiness of their equipment for inspection.**
