within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
