Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

### 4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 5. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

### 6. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

#### 9. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

##### **1.0 In the case of conventional electrodes**

i) Relevant AWS or BIS codes must be mentioned against each type of electrode. Electrodes matching the given AWS & BIS code, physical properties, and Chemical Composition in undiluted weld metal deposit supported by a Test Certificate from a Laboratory approved by NABL will only be accepted. The supplier must submit documentary evidence along with the offer.

ii) Product Literature from the OEM must show the product certification by ABS or IRS.

2.0 Bidder should be either the manufacturer of the Electrode or its authorized dealer having a valid Authorization Certificate. The Authorization Certificate against each electrode will be required and the same should be uploaded in the GeM portal by the OEM for their respective Authorized Dealer.

3.0 Bidders shall quote only one electrode against each Material Code. No alternative offer of electrodes will be considered.

4.0 Authenticated Batch Test certificate from NABL Accredited Labs must be furnished along with the supply or else the material will not be acceptable. Bidders must furnish valid NABL Accreditation of the Test Lab - along with the Offer.

5.0 Warranty certificate of the electrodes as per OEM's standard Warranty policy shall be furnished along with the supply.

6.0 Packing: The bidder should provide vacuum-sealed packaging for low hydrogen electrodes (E7016 & E7018) in small capacities of 2 KG and 4/5 KG. Additionally, the bidder must supply all the electrodes in OEM's standard air-tight carton packaging to prevent any damage during transportation.
