Brief Description of the Approval Granted by Competent Authority	This is to certify that Oil India Limited is a Central Public Sector Enterprises under the Ministry of Petroleum and Natural Gas (MOPNG) and are engaged in oil & gas exploration and production activities. Oil India Limited has adopted Purchase Preference policy linked with Local Content issued by MOPNG vide notification no. FP-20013/2/2017-FP-PNG dated 17.11.2020 and the original policy was approved by the Cabinet. This policy is applicable for tender value more than Rs. 1 Crore to treat the local supplier as Class I, Class II and Non Local Supplier and to extend the benefit of purchase preference accordingly as per policy. Since, the estimated value of the subject tender is less than Rs. 1 Crore, no Purchase Preference Policy shall be applicable against this tender.

Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**2. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**3. Scope of Supply**

**4. Generic**

### **Special Terms and Conditions**

1.0 Bidder other than OEM must enclose authorization letter (in original) from the manufacturer.

2.0 Bidder must confirm the following in their offer:

i) Blowdown of valves shall be  $\leq 20\%$ .

ii) Limit for set pressure adjustments allowed in the valve spring shall be (+- 10%)

iii) Set pressure tolerances: (+-3%)

iv) Valves must be certified by any agency approved by ASME for flow capacity test.

v) Design calculation of fluid handling capacity of the valves to be submitted along with the offer.

3.0 Bidder must submit technical data sheet and product catalogue along with their offer. Bidder shall clearly indicate / highlight their offered product in their catalogue at the time of the bid.

4.0 Materials must have identification mark / stamp / purchase order no. on each piece of the item supplied. Size, capacity, pressure rating & set pressure etc. also should be indicated on the plate provided on the body of the valve.

5.0 Fabrications shall only be carried out after getting drawing approval from OIL (in case Purchase Orders are placed on a particular Vendor).

6.0 All the valves shall be inspected by any of the OIL approved Third-party inspection agencies i.e. M/s Lloyd's or M/s Bureau Veritas or M/s IRS or M/s Rites or M/s DNV only considering the following:

a) Radiography of body & bonnet, mechanical & chemical properties of the materials used, dimensional checking of the body & threads as per the specifications of the purchase order. All necessary certificates will be issued by the Third-party inspector and shall be submitted along with the supply. EN 10204 3.1 TC shall be provided for TPIA review.

b) Each valve shall be subjected to the following tests & test certificate should be furnished along with the supply:

i) Set pressure test & popping point consistency test.

ii) Shell pneumatic test by air.

iii) Inlet hydro test at 1.5 times of the set pressure.

iv) Seat tightness test as per API RP-527.

**(NOTE: TPI shall be in the scope of the Supplier. Bidder is to quote accordingly.)**

7.0 OIL reserves the right to depute its Engineer for final inspection before despatch of the materials for which 15 days advance intimation will be required.

8.0 All materials must be guaranteed for fabrication, workmanship & performance for a period of 18 months from the date of dispatch or 12 months from the date of commissioning whichever is earlier & the relevant warranty/guarantee certificate to that extent shall be submitted to OIL along with the supply.

9.0 The valves shall be ASME UV stamped. Bidder shall submit a valid ASME UV Stamp Certificate (of the OEM) at the time of bid submission.

10.0 Bidder to confirm point wise compliance with the enquiry requirements. Deviations from enquiry specifications, if any, must be highlighted in the offer.
