Brief Description of the Approval Granted by Competent Authority	This is to certify that Oil India Limited is a Central Public Sector Enterprises under the Ministry of Petroleum and Natural Gas (MOPNG) and are engaged in oil & gas exploration and production activities. Oil India Limited has adopted Purchase Preference policy linked with Local Content issued by MOPNG vide notification no. FP-20013/2/2017-FP-PNG dated 17.11.2020 and the original policy was approved by the Cabinet. This policy is applicable for tender value more than Rs. 1 Crore to treat the local supplier as Class I, Class II and Non Local Supplier and to extend the benefit of purchase preference accordingly as per policy. Since, the estimated value of the subject tender is less than Rs. 1 Crore, no Purchase Preference Policy shall be applicable against this tender.

Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

4. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

5. Buyer Added Bid Specific ATC

BID EVALUATION CRITERIA(BEC)/BID REJECTION CRITERIA(BRC):

The bid shall broadly conform to the specifications and terms and conditions given in the bid document. Bids shall be rejected in case the items offered do not conform to required parameters stipulated in the technical specifications. Notwithstanding the general conformity of the bids to the stipulated specifications and the terms and conditions, the following requirements shall have to be particularly met by the bidders without which their bids shall be considered nonresponsive and rejected.

A. Technical:

1. Previous Supply Experience: The Bidder must have experience of successful supply of at least 50 cubic meter of "SPECIAL QUARTZ SAND, SiO₂=99%, MESH SIZE 20-40" in previous Five (05) years reckoned from the original bid closing date in any of the followings:

a) Central/State Govt. Organization

OR

b) Public Sector Undertaking

OR

c) Public Limited Companies.

Documentary evidence in respect of supplying the above-mentioned item, the bidder should submit the following documents as applicable:

i) Copy(ies) of Purchase Order(s) / Contract document(s)

and

ii) Any one or combination of the following documents that confirms the successful execution of each of the purchase order(s) / contract(s) -

a) Completion report / performance certified from the clients,

b) Bill of lading.

c) Delivery challan / invoice etc.

d) Any other documentary evidence that can substantiate the successful execution of each of the Purchase Order(s) / contract(s) cited above.

NOTES: The Date of Purchase Order(s) / Contract document(s) need not be within 05 (Five) Years reckoned from the original bid closing date of this Tender. However, the execution / completion of the same should be within 05 (Five) Years reckoned from the original bid closing date of this Tender.

Special terms and conditions:

1. Items may be delivered in batches, not exceeding 3 lots.
2. Items should be packed in good quality HDPE bags capable of safe storage of the item for at least 2 years from the date of receipt at field engineering department, OIL, Duliajan.
3. Items shall not be packed in bags exceeding 50 KG each.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
