Subject: Final Terms and Conditions for Acceptance of Central Government Authorization for laying, building, operating or expanding Numaligarh-Siliguri Petroleum and Petroleum Products pipeline under regulation 17(1) of the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand Petroleum and Petroleum Products Pipelines) Regulations, 2010.

- (iii) PNGRB vide letter no. PNGRB/Auth/3-PPPL(08)/2020 dated 29.09.2020 issuing provisional Terms and Conditions (T&C).
- (iv) OIL's letter dated 02.04.2021 requesting PNGRB for amendment in provisional T&C.
- (v) PNGRB vide letter no. PNGRB/Auth/3-PPPL(08)/2020 dated 19.08.2021 issuing amendment in provisional T&C.
- (vi) OIL's letter No. PL:4/1-33/137/2021 dated 29.09.2021 accepting provisional Terms and Conditions (T&C) and its amendment.

Sir,

With reference to the provisional Terms and Conditions for Acceptance of Central Government Authorization for laying, building, operating or expanding Numaligarh-Siliguri Petroleum and Petroleum Products pipeline issued to OIL vide PNGRB's letter no.

V

PNGRB/Auth/3-PPPL(08)/2020 dated 29.09.2020 and its subsequent amendment issued vide PNGRB's letter dated 19.08.2021, the Petroleum and Natural Gas Regulatory Board finally accepts the information submitted by you under Regulation 17(1) of PNGRB (Authorizing Entities to Lay, Build, Operate or Expand Petroleum and Petroleum Products Pipelines) Regulation, 2010. Further, on the basis of your submissions made, following terms and condition have been finalized by the Petroleum and Natural Gas Regulatory Board which shall be applicable during the operative phase of the said pipeline system.

- 2. Petroleum and Petroleum Products Pipeline System:
- a) <u>Technical Details of Numaligarh-Siliguri Petroleum and Petroleum Products</u> pipeline:
- (i) Petroleum Products Transported: MS, SKO and HSD
- (ii) Length: Total 660 km.
- (iii) Diameter: 16 inches
- (iv) **Design Pressure**: 84 kg/cm²
- (v) System Capacity: 1.721 MMTPA
- (vi) Injection Point: Numaligarh Refinery Limited (NRL)'s dispatch terminal, Numaligarh
- (vii) Terminal Point cum Receipt Station: NRL's receipt terminal, Siliguri
- (viii) Intermediate Pigging Station: Sekoni, Noonmati, Bongaigaon and Madarihat

The route map of Numaligarh-Siliguri Petroleum and Petroleum Products pipeline is attached at **Annexure-1**.

- b) The system capacity of Numaligarh-Siliguri Petroleum and Petroleum Products pipeline (NSPL) shall be equal to 1.721 MMTPA with no available common carrier capacity as on date in view of long term Product Transportation Agreement executed between OIL and NRL. The capacity expansion of NSPL would be dealt in line with the relevant PNGRB Regulations.
- * Note: These capacities are accepted as provisional and the final capacities shall be determined as per the provisions of the PNGRB (Determining capacity of Petroleum, Petroleum products or Natural Gas Pipeline) Regulations, 2010.
- 3. The authorized entity shall be required to take prior approval from the Board for creation of any lien or charge or hypothecation on the assets of the pipeline to secure finances for the project and furnish details of utilization of funds.

- 4. The entity shall charge tariff in terms of PNGRB (Determination of PPPL Tariff) Regulations, 2010 as amended from time to time.
- 5. The furnishing of performance bank guarantee of the amount as specified in Regulation 8(1) is the guarantee for meeting the quality of service obligations and requirements of PNGRB during operating phase of the project. The entity shall abide by the service obligations specified under relevant regulations.
- 6. In case the authorization of the entity is terminated, the Board may assign the rights and obligations to any agency or another entity on such terms and conditions, as it may deem fit. Further, the entity may be required, as per the directions of the Board, to continue the operations of the Petroleum and Petroleum Products Pipeline at the same level till another agency or entity appointed by the Board takes over the full control of the Petroleum and Petroleum Products Pipeline.
- 7. The entity shall comply with the provisions under-
- a. the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand Petroleum and Petroleum Products Pipelines) Regulations, 2010;
- b. the Petroleum and Natural Gas Regulatory Board (Determination of Petroleum and Petroleum Products Pipelines Transportation Tariff) Regulations, 2010;
- c. the Petroleum and Natural Gas Regulatory Board (Determining Capacity of Petroleum, Petroleum Products and Natural Gas Pipeline) Regulations, 2010;
- d. the Petroleum and Natural Gas Regulatory Board (Codes of Practices for Emergency Response and Disaster Management Plan) Regulations, 2010;
- e. the Petroleum and Natural Gas Regulatory Board (Guiding Principles for Declaring or Authorizing Petroleum and Petroleum Products Pipelines as Common Carrier or Contract Carrier) Regulations, 2012;
- f. the Petroleum and Natural Gas Regulatory Board (Levy of Fee and Other Charges) Regulations, 2007;
- g. the PNGRB Act and any other regulations notified by the Board from time to time, as may be applicable.

- The entity shall comply with any other term or condition which may be notified by the Board in public interest, from time to time.
- 9. You are requested to confirm your acceptance in the space provided below and return the same in original.


