Oil India Limited signs MoU with GAIL (India) Limited to enhance collaboration across natural gas value chain

New Delhi, [30.09.2025]: Oil India (OIL) today signed a Memorandum of Understanding (MoU) with GAIL (India) Limited (GAIL) to strengthen cooperation across the natural gas value chain and unlock synergies for expanding access to cleaner energy across the country.
