This is for general information of all concerned that due to receipt of excess number of eligible bids against **Zones B, C & D** (1st preference) compared to Company's requirement as stipulated in the NIT of the above IFBs, it is decided to select the successful bidders of zones B, C & D through Draw of Lots (DoL) on **21st Feb, 2017 at 9:00 a.m. (IST)** at Contracts Department, Duliajan as per terms and conditions of the Bid Document. If the DoL is not completed within 21st February, 2017, the same will be continued on the next day.

2.0 All the eligible bidders are hereby advised to attend the office of the undersigned on the date and time as fixed above.

4.0 The draw of lots for selecting the successful bidders shall be conducted as per the following procedure:

4.1 Draw of Lots shall be conducted by Tombola.

4.2 For each tender of Zones B, C & D, Draw of Lots will be conducted separately.

4.3 The eligible bidders of each tender of each of the above mentioned zones will be assigned serial numbers separately, in the increasing order of their Vendor codes. Such serial numbers will start


from 101 where the total number of bidders exceeds 99, i.e. the bidder having the lowest 'number value of Vendor code' will be assigned 101 and all the bidders will be assigned serial numbers in the order of increasing number value of their vendor codes. If the total number of bidders is less than or equal to 99, the serial numbers starting from 1 will be assigned to the bidders.

- 4.4 The serial number of all the eligible bidders for Draw of Lots shall be displayed for each tender zone-wise in the Notice Board, Contracts Department, OIL, Duliajan.
- 4.5 If the total number of bidders is more than 99, there will be three Tombola cages for the digits of unit (Ones), tens and hundreds. The Unit placed Tombola cage will be used to draw the unit place digit; similarly, tenth placed Tombola cage will be used to draw the tenth place digit and hundredth placed Tombola cage will be used to draw the hundredth place digit of the assigned number. However, if the number of bidders is less than or equal to 99, then the whole number will be picked up directly through Tombola instead of picking up different digits of the number separately.
- 4.6 Draw of Lots (Lottery) will be done by a member from the public/bidder present at the time of Lottery and the person drawing the same will be required to put his/her signature against the numbers drawn by him/her.
- 4.7 Audio and video recording of the proceedings of the lottery shall be done depending on availability of such system.
- 4.8 Total number of seats and number of eligible bidders against each tender in respective zones for which the DoL will be conducted shall be displayed prior to Draw of Lots on the Notice board.
- 5.0 Some bidders, who opted for Zones B, C & D, have now been submitting letters showing their willingness to shift to different zones where vacancies are there. If due to such shifting of bidders (before the stipulated date and time of DoL), the number of bidders in these zones becomes equal to the Company's requirement, then DoL will not be held for these zones.
