

**NOTIFICATION ON UPGRADATION
of OIL's Registered Civil Contractors from class 'D' to Class 'C'**

This is for general information of all concerned that 248 numbers of OIL's registered 'D' class civil contractors applied for upgradation of their firms to class 'C', in response to Company's Notification CONT/CIV/995/2016 dated 05-07-2016. After evaluating the documents submitted by the contractors as per the upgradation criteria which were published vide above mentioned notification, it has been found that the following contractors have secured the top 163 ranks.

Therefore, Company has decided to upgrade the following 163 numbers of OIL's registered class 'D' civil firms to OIL's registered class 'C' firms after the additional amount of one-time security deposit is submitted by the contractors. The contractors, against which, "Affidavit Required" is written in the 'Remarks' column, are also required to submit an affidavit as mentioned in the last paragraph of this notification.

The contractors are advised **not** to deposit the whole amount of ₹44,000/-, but to deposit the additional amount only *[to make the total amount of one-time security deposit equal to ₹ 44,000/- (Rupees Forty Four Thousand only)]*, within **31-03-2018**.

Against 30 numbers of contractors in the above list, a note 'Affidavit Required' has been mentioned in the 'Remarks' column; the reason being, there are minor differences in the spellings of their names. The spellings of their names present in the educational certificates and the names recorded in Company are not matching. Concerned contractors are advised to visit the office of the undersigned to check the details of spelling mismatch and to submit the affidavit accordingly. Upgradation to Class 'C' will be given to such firms subject to submission of a court affidavit in stamp paper accepting such discrepancy in submission of their documents and declaring that both the names are of the same person.
