INVITATION FOR EXPRESSION OF INTEREST (EOI) (REF: OIL/NEF/GLOBAL/EOI/025/2015)

FOR

CHARTER HIRE OF DRILLING RIG

Sub: Charter Hire of One No. 2000HP (Minimum) Capacity Land Drilling Rig Package including Top Drive System & Effluent Treatment Plant (ETP) with Crew and Services for exploratory Drilling in Mizoram, India (NELP-VI Block: MZ-ONN-2004/1) for a period of one year.

A. PREAMBLE: Oil India Limited (OIL), a premier public sector undertaking of Govt. of India, is engaged in the business of Exploration, Production & Transportation of Crude Oil & Natural Gas as well as production of LPG. Its operations are largely based in the north-eastern part of India particularly in Mizoram, Assam and Arunachal Pradesh but have also extended its activities in different parts of India and abroad.

A.1 Expression of Interests (EOIs) are invited from experienced Service Providers meeting the pre-qualification criteria as mentioned in para "C" below for Chartered Hire of 1 No. 2000 HP (Minimum) Capacity Land Drilling Rig Package together with Top drive System and suitable capacity Effluent Treatment Plant (ETP) for drilling oil & gas exploratory wells for a period of one (1) year in NELP-VI Block: MZ-ONN-2004/1 in the State of Mizoram, India.

B. BROAD SCOPE OF WORK:

To drill onshore wells through chartered hire of one (1) No. of Land Drilling Rig Package of capacity 2000 HP (Minimum) alongwith Top drive System and suitable capacity Effluent Treatment Plant with all associated equipment/tools & services for a period of one (1) year. The wells will be straight vertical holes with formation pressure above hydrostatic. Well depths are expected to be in the range of 3500-5500 meters. However, depths of the wells may increase or decrease at the option of Company (OIL) within the rated capacity of the rig.

Note - The roads leading to the drilling locations in Mizoram are in hilly terrain with sharp turnings and steep gradients where the maximum single load with carrier/trailer should not exceed 35 MT for transportation.

C. PRE-QUALIFICATION CRITERIA:

The interested parties must have adequate capability and experience in providing the above services on similar projects in petroleum E&P sector and submit the details of the assignments carried out and completed till date in support of their experience. The interested Service Providers/Vendors must fulfill the following minimum prequalifying criteria for the purpose of empanelment / short-listing and issue of tender documents for hiring the Services:

- **1.0 Experience:** The interested Vendors/Contractors must have the following experience during the last seven (7) years as on the scheduled EOI submission date.
 - (i) Minimum one (1) year continuous experience of providing drilling services with minimum 1400HP capacity Rig on chartered hire basis.
 - (ii) Drilling of at least five (5) numbers of oil and/or gas wells with drilling rig of minimum 1400HP capacity, out of which one well should be of depth range of minimum 2500mtrs.
- 1.1 In case the Vendor/Contractor who participates against this EOI is an Indian company/Indian joint venture company, either the Indian company/Indian joint venture company or its technical collaborator/joint venture partner should meet the experience criteria laid down in para 1.0 above.
- 1.2 In case the Vendor/Contractor who participates against this EOI is a consortium of companies, the Leader of the Consortium should satisfy the minimum experience criteria as per para 1.0 above.
- 2.0 The Vendor/Contractor must be in possession of the offered Rig (either owned or leased) as on the EOI submission date and should confirm its present location. Additionally, they must categorically confirm that they can complete mobilisation of their offered Rig Package with requisite manpower at site in Mizoram within short notice of Ninety (90) days, in the event of a contract.
- 3.0 The Horsepower rating of the Rig should be minimum 2000HP. Further, the Rig should be Diesel Electric, having self-elevating mast and sub-structure (as per API standard i.e., conforming to API 4F specifications). The Rig would have to be equipped with top drive system and proper effluent treatment plant.
- **4.0** The offered rig must have a residual life of at least seven (7) years as on EOI submission date. The Vendor/Contractor must categorically confirm the same.
- **5.0** Vendors/Contractors who meet the above pre-qualifying criteria may submit their EOI with supporting documents as under:
 - (a) Details of jobs completed during last seven (7) years prior to submission of EOI in tabular form as per format attached vide ANNEXURE-I.
 - (b) Details of current work in hand in tabular form as per format attached vide ANNEXURE-II.

- (c) Complete Technical specifications/details of the Rig offered together with confirmation of its residual life and present location.
- (d) Copy of ownership or Agreement of lease/purchase, if any.
- (e) Financial standing of the Vendor/Contractor in terms of annual financial turnover for last three (3) accounting years as per format attached vide ANNEXURE-III or copy of audited Balance Sheet, Profit & Loss Accounts etc.
- **NOTE:** (i) All copy of documents submitted alongwith the EOI must be clear, legible and self-certified.
 - (ii) OIL INDIA LIMITED reserves the right to check physically the original documents.
 - (iii) The EOI is liable to be ignored in case of submission of any misleading/ false representation by the Vendor/Contractor in the form of attachments and statements.
 - (iv) OIL INDIA LIMITED reserves the right to ignore any or all EOIs without assigning any reasons thereof.
- **D**. This EOI is not an invitation for bids. Based on the EOI responses, OIL may shortlist the parties who meet the qualifying criteria given in Para 'C' above and may float a limited tender on the short-listed parties specifying detailed BEC/BRC.
- **E.** Interested parties are requested to submit 2 (two) copies of their EOI together with all information / documents in sealed envelopes superscripting "EOI ref. number" on the cover of envelope, which should reach the following address **on or before** 12th May, 2015 (15:00 hrs.- IST):
