

EXPRESSION OF INTEREST (EOI) No. OIL/KGB/EOI-35

For

Construction of approach road of 190M length, plinth, effluent pit, road over plinth, laying of impervious layer and other ancillary job to suit E-3000 rig out fit for proposed Drilling location Loc-16 (Prospect G), KG-Basin (Gauthomi-Godavari area NELP-VI,Block:KG-ONN-2004/1) at Yedurlanka Village under I-Polavaram Mandal, East Godavari District, Andhra Pradesh including supply of all materials.

Oil India Ltd, Nookalamma Temple St, Ramaraopeta, Kakinada, Andhra Pradesh, PIN – 533004, a Government of India “NAVARATNA” category Enterprise with its Field Headquarters at Duliajan, Assam, India engaged in the business of Exploration, Production and Transportation of Crude Oil & Natural Gas and Production of LPG, has planned to construct a drilling plinth to suit E-3000 rig outfit for proposed drilling location at Yedurulanka, I-Polavaram Mandal of East Godavari District, Andhra Pradesh.

Therefore, OIL invites EOI from reputed parties/ firms having requisite experience in the field of Construction of drilling plinth.

2.0 SCOPE OF WORKS:

The scope of work envisaged under this tender covers as per tender specifications, drawings and standards etc. In general job shall be done as per Andhra Pradesh Common SOR, CPWD specifications. However brief specifications are given here under for general guidance purpose of the tenderers. The job scope includes Earth work, construction of plinth with filling sand, laterite soling, gravelling and WBM, road over plinth, effluent pit, hard-standing, Security hut, Executive and Workmen toilet, Cement shed, Chemical shed, Erection of 2.4m high fencing, with barbed wire and gate, PCC, RCC, Sand bagging, erection of tubular structure, temporary structure, plinth and road maintenance etc. as per drawings, and all other activities including civil / sanitary / plumbing as spelt out in the detailed drawings and specifications. It shall be clearly be noted that the bidders are required to give their lump-sum rates taking into consideration all aspects as per site requirements and specifications enclosed along with this tender document. Quoted offers shall be inclusive of all materials and labour and all other taxes & levies including service tax and VAT. Water and Power shall have to be arranged by the contractor for execution of the tendered work. The contractor shall be responsible to complete the entire work in all respects including obtaining all necessary permissions required to be taken from any agencies like Government Department, Private & Public Authorities at no additional cost to Oil India Limited and also any other works necessary to complete the job though especially not covered in the scope of work. In general, the scope of work covers the following but not limited to:

- a. Tree felling/ removal of cut trunk
- b. Earth work in excavation in all kinds of soils and in all lead & lift.
- c. Filling with sand (filling)
- d. Laterite soling

- e. WBM with 63mm nominal size stone aggregate
- f. gravelling
- g. PCC 1:3:6.
- h. Barbed wire fencing with RCC posts and steel gate etc.
- i. Hume pipe Culvert
- j. Fire water reservoir
- k. Retainer pit
- l. Cement shed
- m. Chemical shed etc.

3.0 OIL invites reputed parties/ firms with demonstrated track record of timely completion to express their interest to participate in the competitive bidding process at a later date. Only companies possessing proven record of performance of successfully completing preparation of drilling plinth need to respond.

4.0 Parties/ Firms are requested as a minimum, to submit the following documents and details to confirm their interest:

- i. Letter of interest clearly indicating the Project reference.
- ii. Detailed Company Information with Organization structure, list of man power with CVs of key personnel.

4.1 TECHNICAL

4.1.1 Experiences of having successfully completed similar works during last 7 years ending on 31.03.2015.

"Similar work" mentioned above means the following:

Construction of Exploratory and Development Drilling Location including approach roads leading to Drilling Locations with Gravel/ WBM/ Black-topped.

4.1.2 The minimum value of any of the above work satisfactorily executed during the last 7 (seven) years ending on 31.03.2015 should be either of the following-

- i) One single contract of value Rs 336.14 lakhs
- ii) Two contracts, each one of value Rs. 210.09 lakhs
- iii) Three contracts, each one of value Rs. 168.07 lakhs

Documentary evidences of job experience as stated above should be in the form of photocopies of Letter of Intent/Letter of Allotment / Work-order along with respective Completion Certificate(s). The Certifying Authority for completion certificates should be not below the level of Chief Engineer / Chief Manager in case of PSUs and equivalent levels in Govt. organizations/Private organizations.

4.1.3 PF code number issued by the appropriate Govt. authority or exemption certificate from the concerned authority or a declaration in stamped paper that provisions of the PF act are not applicable to him/them and in case PF is to be deposited later on, the same will be deposited by the bidder.

4.1.4 PAN and VAT Registration number.

4.1.5 Documentary evidence in support of sound financial standing and Bank Account.

4.1.6 The bidder should have average annual financial turnover for the last 3 (three) accounting years should be at least Rs. 126.05 lakhs. The proof of Annual Turnover should be either in the form of Audited Balance Sheet/Audited Annual Reports or Certificate from Chartered Accountant Firm indicating their Membership / code number along with Profit & Loss Account.

4.1.7 All the certificates and documentary evidences required to be submitted in support of Para 4.0 (4.1.1 to 4.1.6) above should be clearly legible and duly attested by gazetted officer as well as by the applicant along with official seal. Illegible /incomplete certificates or documents will not be considered for evaluation.

4.1.8 Bidders must fully mobilize all equipment and personnel and be prepared to commence work within 7 days from the date of issue of Work Order. Bidders must provide categorical confirmation of their capability and intent to meet this timing in their Technical Bid otherwise their Bid will be rejected.

4.1.9 The bidders must be possessed /Ownership in their own name / firm OR must produce an undertaking / affidavit from the owners for providing services of the following minimum numbers of equipment for satisfactory completion of location preparation jobs on stamped paper:

- (i) Dumper / Truck Two (02) numbers
- (ii) Sump pump One (01) number
- (iii) Excavator One (01) number
- (iv) Road Roller 8-10T Capacity (01) number
- (v) Vibratory Roller 8 T Capacity (01) number

4.1.10 The contractor/firm must have their own competent persons who have sufficient knowledge to go through the specifications of the contract, sort out minor difficulties/details of site and ensure the execution of the works according to our requirements and as per the scope of the contract. The persons must be capable to work in all types of terrain, hazardous area, hill etc.

4.1.11 The Partnership Firm having Joint Ventures/Consortium/Tie-up will be qualified to quote against the Tender subject to the following:

- (i) They have proper and valid MOU clearly indicating the role and responsibility matrix of each member.
- (ii) Any of the partners of Joint Ventures/Consortium/Tie-up must meet the qualifying criteria as indicated in 4.1.1 and 4.1.2 above.
- (iii) One of the partners must confirm unconditional acceptance of full responsibility of executing the contract.
