    - b) Should be easily accessible for long body trailer movement and preferably near the road.
    - c) Must be in and around ADB road, Port road in Kakinada Town for easy movement of long bed trailers.
    - d) Electricity, Toilets and running water & proper lighting.
    - e) Security Gate & Hut.
  - (iii) In addition to above, the Open yard to be offered shall have:
    - a) Free supply of Electricity & provision of required lighting by party.
    - b) Free round the clock security by party.
    - c) Providing 4500 Sq. mtr. area for 1 year by party for Tubular Servicing & maintenance purpose.
    - d) 30 nos. rack built by party for storage of tubular.

- e) Party will undertake shifting of stored tubular from the yard of M/s. Omega Pipe Inspection & Services to their facility. For this purpose, party has to make assessment.
