 - d) Security Gate & Hut with round the clock security provided.
 - e) 30 nos. racks built for storage of tubulars.
 - f) The facilities to have proper boundary walls/fences from all sides for safe keeping of goods.
- 2.0 Firms are to categorically indicate availability of above facilities/requirements in their EOI. In addition to above required facilities, the parties may indicate any additional facilities available to support smooth operations.
- 3.0 Facilities are required on lease initially for about 3 years (extendable by 1 year at same rates, terms and conditions) so as to store materials like heavy steel tubulars (casings, tubings etc.), drilling consumables, production consumables etc.

 - (i) Relevant documents towards possessing the facility of yard & warehouse.
