OIL INDIA LIMITED (OIL), a Government of India “NAVARATNA” Category Enterprise, engaged in the business of Exploration, Production & Transportation of Crude Oil and Natural Gas and Production of LPG in India invites Expression of Interest (EOI) for Replacement of 13 Nos. Hand Operated Overhead Travelling (HOT) crane of existing GCS's.

Expression of Interest (EOI) is invited from indigenous reputed parties/firms having experience for the above services. Interested parties are requested to submit their EOI with their credentials and supporting documents as detailed in the website www.oil-india.com to Head-Contracts, Oil India Limited, Duliajan-786602, Assam (India) in two copies indicating the **EOI No. EOI/PGAS/032/2015** on the cover of the sealed envelope on or before 24/06/2015 (15:30 PM).

EXPRESSION OF INTEREST (EOI)

Replacement of hand operated overhead travelling (HOT) cranes.

Expression of Interest:

Expression of interest is requested by Oil India Limited (OIL) from turnkey solution/ service providers / crane manufactures for replacement of 13 nos. double girder 8 tonne capacity HOT crane in upper Assam OIL fields namely at NHK Jorraján , Hapjan and Moran fields.

Preambles:

Oil India Limited (OIL), a national oil company in India engaged in exploration, drilling, production and transportation of crude oil and production of LPG intends to replace the existing double girder 8 tonne capacity HOT crane

in running compressor stations(GCSs) from interested crane manufactures / service providers.

The existing double girder HOT cranes are having 20.24 meter span, height of lift 6.5 meter and is operating on 60 lbs/yd gantry rail.

Background:

The above HOT cranes were installed in Gas Compressor sheds during the early 80s. These cranes are de-rated by Govt. Approved Agencies due to wear and tear for prolonged use. OIL intends to replace these cranes with new cranes having 8 tonne capacity on the existing shed /structures so that day to day maintenance of the compressor packages can be done safely.

Brief Scope of work for replacement of cranes:

- i) Checking of existing gantry rail(s) and replacement if required.
- ii) Design of new 8 tonne capacity crane(s) under existing condition of shed and gantry.
- iii) Dismantling & removing the existing crane(s) and
- iv) Fabrication, Supply, Erection, commissioning and testing of the new cranes.

Qualification criteria of the parties

The interested parties must fulfill the following criteria to become eligible for the proposed jobs :

A. Minimum one of the following :

- i) The party should be a manufacturer of HOT /EOT cranes and must have supplied and commissioned at least 2 nos.of HOT/EOT cranes with minimum capacity of 8 tonne of minimum 15 mtrs. Span in last 5 years
- ii) Party should have experience in turn key completion of at least 2 nos sheds with HOT/EOT cranes of minimum 15 mtrs. Span. with minimum capacity of 8 tonne in last 5 years.

Note: Documentary evidence for above needs to be enclosed along with the letter of interest from the parties.

B. The bidder should have an average annual turnover during the **last three years ending 31.03.2014 at least of Rs.1,10,10,000.00 (Rupees One Crore Ten Lakhs Ten thousand only).**

For proof of Annual turnover, the following documents/ photocopy must be submitted along with the EOI:

- i) Certificate from a Chartered/Cost Accountant with membership No /Firm Registration No. certifying annual turnover for last 3 (three) years.**

OR

ii) Audited copy of Profit and Loss account/ balance Sheet for last 3 year.

Submission of EOI:

The interested parties meeting above requirement must forward their letter of intention along with initial proposal and relevant supporting documents meeting the qualification given above. The parties are require to submit their letter of interest to OIL in two copies in seal cover superscripting with Expression of interest EOI No. **EOI/PGAS/032/2015** for Replacement of hand operated overhead travelling (HOT) cranes.

Discussion & Presentation

The shortlisted parties shall attend a discussion and give a presentation about their technical capability, credentials, experience of work / project and how the parties are going to execute the proposed jobs. The tentative technical cum commercial proposal presentation to be organized by OIL in one of the two location Guwahati / Kolkata. Tender document would be finalized taking input from the above presentation/discussion. Limited tender shall be floated with the participating parties shortlisted on the basis of EOI for further participation of Tender.
