Scope of Work:

To carry out submerged pipeline laying across the river Brahmaputra in Guwahati having an approximate length of 5050 Meters by outsourcing services from reputed service providers with the following qualification criteria.

a) Qualification Criteria :

The service providers shall have the experience of successfully carrying out Trench less crossing of hydrocarbon pipelines of minimum size 406.4mm (16”) OD with HDD/Micro Tunneling/ Any other trench less technology of minimum 2000 Meters length .
