Subject: Expression of Interest for "Carrying out internal cleaning and restoring pigging operation of an old in service crude oil delivery pipeline of size 250mmNB, by adopting chemically or mechanically progressive pigging methodology, in the Oil & Gas production area of OIL INDIA LIMITED, in the state of Assam".

1. PREAMBLE:

OIL INDIA LIMITED (OIL), a Government of India Enterprise under the Ministry of Petroleum and Natural Gas, is a premier up-stream Oil Company engaged in the business of Exploration, Production & Transportation of Crude Oil & Natural Gas as well as production of LPG, having its Headquarter at Duliajan, Assam in India.

In OIL's Oilfield production areas, for transportation of Crude Oil and Natural Gas from production well heads to process installations and then to Tank farms and Gas Gathering Stations there are many pipeline networks connected. In one of such crude oil delivery pipeline, we are intending to adopt a methodology and to frame a service contract for aforementioned work by inviting Expression of Interest (EOIs) from reputed, experienced, expertise, start-ups companies / service providers/ contractors.

2.0 Objective and Scope of work:

- ➢ OIL INDIA LIMITED is planning to carry out internal cleaning and restoration of pigging operation of an old 250 mmNB in-service Crude Oil delivery pipeline of approx. length 22.6 KM. This pipeline was constructed in the year 1995 and was under pigging operation till 2012, after that due to operational requirements the original flow direction was reversed and original starting point became receiving end, since then pigging was not carried out. The objective / scope of work of this pipeline cleaning and restoring pigging operation includes but not limited to the following. The proposal must include the following (but not limited to):
 - I. Pipeline construction and operational data requirements.
 - II. Fluid properties.
 - III. Any piping/pipeline design change requirements and suitability of present scrapper trap system, due to reverse in flow direction in the subject pipeline.
 - IV. Methodology and arrangement required for using chemical solvents for cleaning internal surface of pipeline.
 - V. Methodology and arrangement required for cleaning internal surface of pipeline using Mechanical pig by doing progressive pigging.
 - VI. Methodology and arrangement required for cleaning & pigging mixture of both Chemical plus Progressive pigging.
 - VII. Present industrial practices using these methodologies, if any.
 - VIII. Handling and disposal system required for solvent if used for cleaning purpose.
 - IX. Details about types of solvents and pigs.
 - X. Details about the physical and chemical properties of solvents and pigs.
 - XI. Any specific code or guidelines to be followed for this kind of activities.
 - XII. Solid wax/ pig residue handling/ disposal system requirement.
 - XIII. Standard operating procedure for the adopted methodology.

The service provider(s) may also submit a budgetary quotation against with their proposal.

- **Duration:** Contract duration will be 6(Six) months.
- > Service providers capabilities: Interested companies to demonstrate their capabilities in providing such services.
- > **To explore** technology.
- > To understand the prospective service providers experience and technical capability.
- **To have inputs** from the prospective service providers.

The EOI is expected to provide information of available technology and methodology, prospective service providers and their suggestions thereby assisting in formulation of terms and conditions of any formal tender that may be floated for "Cleaning and Restoring pigging operation in an old crude oil pipeline".

3.0 Technical details of the subject pipeline:

- a. Constructed in the year 1995.
- b. Pipe Grade: API Std. 5L Grade B, ERW pipe, Carbon Steel pipe.
- c. Pipeline diameter: 250mmNB (10.75" OD).
- d. Wall Thickness: 7.8 mm.
- e. Present length under use, in reverse direction 22.6 KM.
 Injection starts from Location NFK to ITF (Tengakhat), 2 more injection points in between, those are Balijan (Deohal condensate) and Bhekulajan (crude oil).
- f. Type of coating coal tar enamel.
- g. Originally designed as piggable pipeline.
- h. Integrity Assessment by NACE DA methodology done recently, MAOP 71 kg/cm2.
- i. All injecting branch points are of 4 inch diameter.
- j. SARA analysis report of crude oil, presently pumping from Location NKF:

Density: 880 to 890 kg/m3.
