1.0 **Introduction**:

Oil India Limited (OIL), a Navaratna Company and a Public Sector Undertaking under the administrative control of Ministry of Petroleum and Natural Gas, Govt. of India, having its fields headquarter at Duliajan, Assam invites Expression of Interest (EOI) from reputed parties / firms having requisite expertise, capabilities and experience in the relevant fields for successfully carrying out the work mentioned in Para No. 2.0 below.

2.0 Scope of work:

To prepare all required documents like KML files / Topo Sheets / Maps related soft copies etc. for obtaining FC and NBWL and other related clearances. Detailed description of job is as under:

- a. Marking of the concerned forest area with Total Station / DGPS.
- b. Mapping including Geo Referencing of Mouza sheets, Delineation of the boundary in Mouza Sheets / Topo Sheet / Satellite Imagery / KML file (patch wise) / Geo-Reference Map / Outer Boundary of Mining Leas Area or any maps sought by MOEF&CC.
- c. Obtaining FRA clearance from District Administration.
- d. Any other documents required / sought by MoEF&CC, if any (Limited to assisting OIL in responding to the EDS sent by MoEF&CC till the acceptance of the proposal by the Nodal Officer, Forest Clearance, Assam).
- e. Mapping of the wells / production facilities / pipelines.
- f. Mapping of the ecologically protected area (National Park / Sanctuary).
- g. Facilities falling within the Eco-Sensitive Zone of the protected areas with distance.
- h. Discussion with forest department and for obtaining the Management Plan of the concerned protected area.
- i. Preparation of the Site Specific Wildlife Management Plan.
- j. Assisting OIL in uploading the documents at the MoEF&CC website.
- k. Assisting OIL in responding to the EDS sent by MoEF&CC till the acceptance of the proposal.



1. For providing any other technical and liaising Services till obtaining of FC and NBWL clearance and prepare related maps, files, documents.

3.0 General Note:

- a. The parties / firms should be responsible for providing the services of experts / consultants to complete their scope of work.
- b. The area / blocks to be covered for above jobs will fall under the state territory of Assam and Arunachal Pradesh.
- c. All the service and any other utility requirement, not specified, but necessary for the above mentioned Scope of Work should be provided as per requirement of MOEF&CC and other applicable statutory bodies.

4.0 **Pre-Qualification Criteria:**

Interested parties / firms shall have to submit the following documents with their EOI for pre-qualification:

- a. Experience of successful completion of minimum 01 (one) no. of job of providing 'similar type of services' till completion of the project, during last seven years as on the date of opening of EOI. The party / firm must submit necessary experience certificate from the competent authority in support of their satisfactory completion of the job (At least ONE certificate for providing such services.)
 - "Similar type of service" means Preparation of all required documents for like KML files / Topo Sheets / Maps related soft copies etc. for obtaining FC and NBWL clearance and prepare related maps, files, documents etc. for any Government (Central/State) companies (or) Public Sector Undertaking (Central/State) companies (or) Public Limited Companies (or) Private Limited Companies.
- b. Annual Turnover of the party / firm in any of the preceding 3 financial years should be at least Rs. 3.0 Lakhs. The proof of Annual turnover should be either in the form of audited balance sheet or certification from Chartered / Cost Accountant firm indicating the Code No.
- c. Net worth of the party / firm should be Positive for preceding financial / accounting year. The document submitted in proof of the same should be duly certified by Chartered / Cost Accountant firm indicating the Code No.
- d. PF Code No. & PAN issued by the appropriate Govt. Authority.



- e. All the certificates & documentary evidences submitted must be self-attested. OIL has the right to check the original certificates / documents at any point of time, if desired, and the required documents shall have to be produced by the parties / firms for authentication.
- 5.0 The interested parties / firms may visit the site of work to gather 1st hand information prior to submitting EOI at their own cost. They are also advised to contact <u>CGM (HSE)</u> or his authorized representative in this regard.
- 6.0 OIL may invite the eligible parties / firms to make a presentation to the OIL officials at a date, time & location determined by OIL for which no additional payment will be entertained by OIL. The purpose of such presentation would be to allow them to present their proposed solutions to the OIL and the key points in their proposals.
