"SALE OF SOLID EXTRACT OF THE DESALINATION PLANT AT SECONDARY TANK FARM (STF), MADHUBAN AND INTERMEDIATE TANK FARM (ITF), TENGAKHAT, OIL INDIA LIMITED".

1. EXPRESSION OF INTEREST:

Expression of Interest is invited by Oil India Limited (OIL) from prospective in-country vendors for Sale of solid extract of the desalination plant on immediate as-is-where-is-basis from Secondary Tank Farm (STF), Madhuban and Intermediate Tank Farm (ITF), Tengakhat of Oil India Limited located in the state of Assam.

PREAMBLE:

OIL INDIA LIMITED (OIL), a Government of India Enterprise under the Ministry of Petroleum and Natural Gas, is a premier up-stream Oil Company engaged in the business of Exploration, Production & Transportation of Crude Oil & Natural Gas as well as production of LPG, having its Headquarter at Duliajan, Assam in India. Its operations are largely based in the North-eastern parts of India particularly in Assam and Arunachal Pradesh but have also extended its activities in different parts of India and abroad.

Secondary Tank Farm (STF), Madhuban of Oil India Limited (OIL) is a tank farm designed to store 40,000KL of Crude oil.

Intermediate Tank Farm (ITF), Tengakhat of OIL is a crude oil tank farm having design processing capacity of 7500 Kls/ day.

The treated water coming out of the ETP plant at STF-Madhuban & ITF-Tegakhat is highly saline making it unfit for reuse at the plant. Hence, OIL is in the process of hiring (through etender) the services of suitable vendor/firm/contractor who can carry out desalination of this water thereby bringing down the salinity to a level of making the water suitable for reuse at the plant.

In the process of desalination, a good volume of salt will be produced as final extract in the tune of around 1000 to 1500 Kg per day.

Simultaneously, OIL INDIA LIMITED (OIL) also intends to sell the solid extract of the desalination plant on immediate as-is-where-is-basis from Secondary Tank Farm (STF), Madhuban and Intermediate Tank Farm (ITF), Tengakhat of Oil India Limited located in the state of Assam.

2. LOCATION OF THE AREA:

STF-Madhuban plant where the desalination plant will be established is located at a distance of around 47 Km from Dibrugarh town in Assam. It is located at a distance of around 6 Km from Duliajan.

ITF-Tengakhat plant is located at a distance of around 25 km from Dibrugarh town and is located at a distance of around 25 Km from Duliajan.

3. SCOPE OF WORK:

Scope of work under this EOI encompasses the following jobs (but not limited to):

a) Collection of solid (mostly halite), that would be generated from the proposed desalination plant at STF-Madhuban and ITF-Tengakhat (1000-1500 KG per day).

Detail analysis of the solid extract of desalination plant (generated at the pilot trial of desalination plant at STF-Madhuban) is as follows:

N.B.: Moreover, the sample contains minor amounts of Chloride (Cl⁻), Sulphate (SO₄²⁻) and carbonate (CO₃²⁻) of Iron (Fe²⁺), Magnesium (Mg²⁺), Chromium (Cr⁶⁺), Vanadium, Nickel etc.

Around **1500-2000 kl** of formation water is treated in the ETP at STF-Madhuban plant and around **1400-1500 kl** of formation water is treated at ITF-Tengakhat plant on daily basis. Hence, a considerable volume of salt would be generated (approx. 1000-1500 Kg per day) at the desalination plant. OIL intends to sell this particular solid extract (mostly halite) of desalination plant to interested vendor/firm/contractor.

- b) Packaging to be done with suitable bags for transportation to avoid spillage by the party.
- c) Manpower for the job is to be supplied by the party.
- d) Transportation of the solid from OIL's custody transfer point (STF- Madhuban and ITF Tengakhat) is to be arranged by the party.
- e) Weighing of the salt has to be done at the respective plant/installation by the party.

OIL will provide suitable site at STF & ITF Plant for packaging/handling of the solid.

4. PERIOD OF CONTRACT:

The period of Contract will be for a period of 06 (six) years and shall be extendable for another 01 (one) year as per the terms of the contract.

5. **GENERAL NOTES:**

- i. All documents submitted along with the EOI should be clear & legible.
- ii. The EOI is liable to be ignored in case of submission of any misleading/ false representation by the Contractor/ Vendor/ Company.
- iii. OIL INDIA LIMITED reserves the right to ignore any or all EOIs and also to curtail/enhance the scope of work stated above, if required, without assigning any reason thereof.
- iv. This EOI is non-binding in nature and submission of information should not be considered as

- shortlisting / selection for company in any subsequent RFP/ Tender/ Bid process that may be undertaken in future.
- v. OIL reserves the right to terminate the EOI process at any point of time without assigning any reasons, thereof.
- vi. No participant shall contact OIL on any matter relating to the EOI after the last date of submission of EOI unless requested for so in writing. Any effort by the bidder to influence OIL in the decision making in respect of EOI will result in the rejection of that bidder.
