OIL INDIA LTD (OIL), a premier public sector undertaking of Govt. of India invites the Expression of Interest (EOI) from reputed and established Engineering firms/contractors meeting requisite criteria for empanelment of contractors for executing hydrocarbon pipeline maintenance works of maximum value ₹ 7.00 lakhs as per the scope of work mentioned below:

1.0 Scope of Work:

To provide various services / support services for inspection & maintenance of trunk pipelines viz, OIL's Naharkatiya - Barauni Crude Oil Pipeline & Numaligarh-Siliguri Product Pipeline and IOCL's Guwahati-Siliguri Product Pipeline and Right of way stretching from PS1, Naharkatiya to Barauni Pump Station.

- 2.0 Interested firms/contractor shall have to fulfill following requirements and shall have to submit necessary documents as mentioned below along with their application for pre-qualification for aforesaid work.
 - a) Experience of having undertaken inspection & maintenance jobs of hydrocarbon trunk pipelines (minimum size 355.6mm OD) and RoW / RoU passing through hilly terrain and /or reserve forests and /or national parks as found in NEE Region of India in last 5 years upto 31.03.2014. The aforesaid inspection & maintenance jobs of hydrocarbon trunk pipelines (minimum size 355.6mm OD) must include.
 - Repair of coating on operating hydrocarbon pipelines with CTE/Cold applied tapes and any of the following jobs.
 - 1. Restoration of Right-Off-Way, exposure repairs with boulder sausage and /or bamboo piling and/or gunny bags and other suitable methods.
 - 2. Inspection & maintenance of pipelines suspended on rail/road bridges or suspended independently across rivers.
 - 3. Repair of shorted casing.
 - 4. Pipeline leak repair jobs with safe handling of oil spillage.
 - 5. Extension of casing of NH/Rail /Embankment /Other roads.
 - b) The bidder must be able to provide support services for any pipeline repair jobs within quickest possible time. For the same the bidder must have his registered office and/or his authorized representative stationed within 10 Km radius of any one of OIL's Pump Stations from Naharkatiya to Barauni.

The job experience as detailed in para 2.0 a) above shall be in

- i) Single contract of minimum value Rs **5,00,000.00 Lakhs** OR
- ii) Two contracts each of minimum value Rs **3,50,000.00 Lakhs** OR
- iii) Three contracts each of minimum value Rs 2,80,000.00 Lakhs

Note:

Documentary evidence in support of work experience and fulfilling the requirement as spelt out in clause 2.0 a) & b) must be submitted along with the application. These documents should be in the form of copies of Completion Certificates / Payment Certificates issued by the Owner of a pipeline. However, the originals of these documents shall have to be produced by the bidder, as and when asked for.

- c) Average annual financial turnover as per Audited Annual Reports for the last 3(three) accounting years should be at least **Rs 2.10 Lakhs.** The proof of annual turnover should be either in the form of Audited Balance Sheet or certification from Chartered / Cost Accountant firm indicating the Code / Membership Number.
- d) The Bidder must posses PAN, VAT & Service Tax Regn. No. issued by appropriate Govt. Authority.
- 3.0 The application shall provide the details of work experience and present commitment as per enclosed **Annexure I & II**.
