1.0 PREAMBLE:

OIL INDIA LIMITED (OIL), a Govt. of India "NAVARATNA" category PSU under the Ministry of Petroleum and Natural Gas, is a premier up-stream E&P Company engaged in exploration, production, transportation of crude oil and natural gas and production of LPG. OIL also has presence in the downstream sector with majority equity stake in Numaligarh Refinery. OIL has its Registered Office and its Field Headquarters at Duliajan and its Pipeline Headquarters at Guwahati, Assam. OIL's commitment to growth has enabled the company to spread its wings from the north-eastern part of India to establish pan India presence along with global footprints.

1.1 Project Details:

Construction of OIL's Corporate Office Building & Skill Development Institute (SDI) building at Bamunimaidan, Guwahati, Assam. The total area of the plot is around 5 Bighas 2.2 Lessas (6721 sq.mtr/ 72318 sq. ft).

2.0 OBJECTIVE:

- OIL intends to hire Architect for Design & Architectural Consultancy, Project Management and Construction Supervision Services for Construction of OIL's Corporate office and Skill Development Institute at Guwahati. OIL is looking for Indigenous Architect having expertise, experience of designing and Architectural Consultancy along with Project Management and Construction Supervision Services. This EOI is intended to lookout for such experienced Architect/ Architectural Firm.
- o **Capabilities:** Architect/ Architectural Firm must have experience of designing as well as PMC service.
- o **To understand** the prospective service providers' experience, technical and financial capability.

3.0 Location of Proposed Building:

The proposed buildings are to be constructed on a plot of land situated in Bamunimaidan locality in Guwahati, Assam. Interested Architect/ Architectural Firm may visit the proposed building site for collecting the necessary details of the plot including that of surrounding locations, areas those may have bearings on the Project and understanding the project requirement. Copy of plot plan is attached in **Annexure A.**

4.0 Estimated building size:

Corporate Office Building: Ground Floor + 10 with Basement for parking and utilities. Skill Development Institute Building: Ground Floor + 2 with Basement for parking and utilities. (The size of the buildings is subject to permission from the Competent Authority / Agency.)

5.0 Estimated Cost of building:

Around 250 crores.

Note: The Cost estimate is tentative and indicative in nature and may increase or decrease as per the requirement of the building and area consideration. The cost estimate so mentioned does not include the land cost.

This EOI is expected to provide information of prospective service providers and their suggestions thereby assisting in formulation of terms and conditions of any formal tender that may be floated for Design & Architectural Consultancy, Project Management and Construction Supervision Services for Construction of OIL's Corporate office and Skill Development Institute at Guwahati.

6.0 <u>SCOPE OF WORK:</u> The scope of work/services includes but is not limited to the following:

Architects shall render all comprehensive, professional, and architectural services which may be required for the above job and making functional the above said facilities for use by OIL INDIA LTD. The Architect will extend the entire consultancy services necessary for Conceptualization and Planning of the Project, Architectural Designing and Detailing, carry out detailed engineering, obtain all necessary statutory clearances, prepare the bidding documents for different packages, evaluate the bids, review shop drawings done by Contractor(s), Construction & Project Management Services, obtain building completion and occupancy certificate.

The Architect shall follow all the Govt. of India rules, procedures, regulations and instructions of various agencies having jurisdiction on implementation of the projects, issued from time to time, to ensure strict adherence to laid down procedure.

Broadly, the services to be so rendered by the Architect/ Architectural Firm shall include the following:

- 2. Project Management and Construction Supervision Services.
