This Amendment against GeM Bid No. **GEM/2023/B/4289088 dtd. 08-12-2023** for Procurement of Accommodation Type Bunk House, Office-cum Accommodation Type Bunk House-Final, Recreational Bunk House is being issued to Incorporate New Claus es in the tender:

#### **New Clauses**

#### Accommodation Bunk House

- 1. **Insulation:** 50 mm thick rockwool insulation shall be used for walls and roof.
- 2. **Inner panelling:** All vertical and horizontal corners shall be finished with Aluminium sections. The panelling of side walls and roof shall be off 9 mm thick decorative laminated board.
- 3. **MS sheet thickness:** Roof and outer wall thickness of MS sheet shall be 03 mm each.
- 4. Water Tank: O1 No. of Overhead Water Tank with Capacity: 1000 L

#### Office cum Accommodation Bunk House

- 1. **Insulation:** 50 mm thick rockwool insulation shall be used for walls and roof.
- 2. **Inner Panelling:** All vertical and horizontal corners shall be finished with Aluminium sections. The panelling of side walls and roof shall be off 9 mm thick decorative laminated board.
- 3. MS sheet thickness: Roof and outer wall thickness of MS sheet shall be 03 mm each.
- 4. Water Tank: To provide 01 No. of Overhead Water Tank with Capacity:2000 L

## Recreational Bunk House

- 1. **Transportation and fabrication:** In accordance with maximum permissible size for transportatio n, the recreational bunk house may be taken for final fabrication at delivery site of Oil India Limited . However, the final fabricated size should be approximately 40 X 20 X 9 FEET.
- 2. Air Conditioner: Must in-corporate 02 Nos. of 2 TON Split ACs (Mitsubishi/Voltas/Carrier) make wit

h suitable 16/6A multiplug sockets for connection.

- 3. Insulation: 50 mm thick rockwool insulation shall be used for walls and roof.
- 4. **Inner Panelling**: All vertical and horizontal corners shall be finished with Aluminium sections. The panelling of side walls and roof shall be off 9 mm thick decorative laminated board.
- 5. MS sheet thickness: Roof and outer wall thickness of MS sheet shall be 03 mm each.
- 6. **Sitting arrangement and flooring:** 04 Nos Bench (Size 1000 x 460 mm) to be provided. 02 Nos of side table/racks of strong built for keeping weights, small equipment to be provided. The recreational bunk to be finished with proper rubber matter in the floor section.

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
