- **A.** This Amendment to the Tender is issued to notify the following Changes in tender clauses:
- 1. Clause No. 2.2 of Part-2: BID EVALUATION CRITERIA (BEC)/ PRE-QUALIFYING CRITERIA (PQC) shall be read as below:

2.2 The vehicles offered by the bidder must qualify the following criteria:

- (i) The vehicles offered by the bidder in their bid shall not have vintage earlier than 01.01.2022 (brand new vehicles may be offered) and shall meet the specifications and requirements as mentioned in Clause No. A of [Part-3, Section-III, Special Conditions of Contract (SCC)] of the tender.
- (i) (a) The readily available vehicles offered by the bidder and meeting the specifications as per Clause 2.2 (i) above shall have to be owned & registered in the name of the bidder as per Motor Vehicle Act, 1988 & Central Motor Vehicle Rules, 1989 of India as on the bid closing date of this tender.
 - (b) The brand new vehicles offered by the bidder shall meet the specifications as per Clause 2.2 (i) above must be booked in the name of the bidder as on the bid closing date of this tender.
- (ii) Vehicles registered as **commercial/professional** only will be considered.
- (iii) In support of the above, the bidder shall submit the following documents along with the Technical Bid (Un-priced Techno-Commercial Bid):
 - (a) Undertaking as per prescribed format (**Proforma-A**) with the details of offered vehicles (either registration in the name of the bidder in case of readily available vehicle OR details of booking in case of brand new vehicle) and declaring that if awarded with the contract by OIL, he/she/they will supply the offered vehicle(s) strictly as per the specifications of the tender as detailed in the tender document [Part-3, Section-III, Special Conditions of Contract(SCC)] within the Mobilization period of 02 weeks from the date of issuance of LOA.

(b) Copy of Registration Certificates of the offered vehicles owned & registered in the name of the bidder in case of readily available vehicles,

OR

Copy of Booking details (Booking Invoice from the Authorized Dealer) along with Money Receipt in case of brand new vehicle.

Notes:

- (i) For readily available vehicles offered: In case the address of the bidder in the Registration Certificate of the offered vehicle does not match with the address of the bidder submitted to Oil India Limited (as per Vendor Code of the bidder with OIL or registered with OIL), the bidder shall have to submit a declaration in the form of a **Notarised Affidavit** declaring that the bidder is the same entity with the different addresses as mentioned by the bidder.
- (ii) For readily available vehicles offered: In case the bidder submits "Disclaimer" or "Vehicle Particulars" of the offered vehicle(s) issued from Vahan/Parivahan portal instead of the Registration Certificate, the "Disclaimer" or "Vehicle Particulars" shall be duly certified by the respective DTO/RTO/RTA office.
- (iii) For Brand New vehicle offered: The bidder shall have to submit the technical leaflet of the offered vehicle(s) with all requisite technical details along with the Technical Bid (Un-priced Techno-Commercial Bid) which must comply the specifications and requirements as mentioned in Clause No. A of [Part-3, Section-III, Special Conditions of Contract (SCC)] of the tender
- (c) Copy of Motor Vehicle Tax Payment Receipts valid atleast upto the bid closing date of this tender of the offered vehicles owned & registered in the name of the bidder (for readily available vehicles).
- (v) The bidder shall submit the technical leaflet of any equivalent make & model of the offered vehicle(s) with all requisite technical details as mentioned in the tender along with the Technical Bid (Un-priced Techno-Commercial Bid).
- (vi) Atleast 03(Three) vehicles offered in the bid must qualify the technical criteria as per Clause 2.2, otherwise the bid shall be liable for rejection.
