of obtaining No-Objection Certificate (NOC) on behalf of Oil India Limited from local authorities such as the Tripura Tribal Areas Autonomous District Council (TTAADC) for commencement of seismic survey operations under the tender, before completion of mobilization in both the blocks. OIL shall provide any kind of administrative assistance in obtaining the same, however OIL shall not be responsible in any manner whatsoever for any delay in completion of mobilization or commencement of work due to non-receipt of NOC from local authorities such as TTAADC. The Contractor shall have to submit to the Company, a copy of the NOC obtained on behalf of OIL upon receipt of the same.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations. Also, GeM does not permit collection of Tender fee / Auction fee in case of Bids / Forward Auction as the case may be. Any stipulation by the Buyer seeking payment of Tender Fee / Auction fee through ATC clauses would be treated as null and void.
