Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. Click here to view the file
- 3. The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. The goods for which bids have been invited fall under classification of GST concession and the conditions for eligibility of concession are met by the institution. A certificate to this effect will be issued by Buyer to the Seller after award of the Contract. Sellers are requested to submit their bids after accounting for the Concessional rate of GST.

- 4. In view of the same, an ATC may be incorporated in GeM, viz, "BIDDER/OEM must provide Proforma Invoice for processeing for EC application within 15 days from date of issue of GeM Contract and material should be dispatche after receiving of EC rom DGH."
- 5. Scope of supply (Bid price to include all cost components): Only supply of Goods
- 6. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 7. Buyer Added text based ATC clauses

1.0 BID REJECTION CRITERIA (BRC):

The bid shall conform generally to the specifications, terms and conditions given in this document. Notwithstanding the general conformity of the bids to the stipulated specifications, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected.

A) <u>TECHNICAL</u>:

1. The bidder should be a reputed fabricator and should have the credentials of manufacturing and supplying similar type of racks, Steel Fabricated Huts, Crew Cabins, Bunk Houses, tanks (minimum 100 bbls capacity) in the past. Necessary evidence in the form of order copies / proof of supplies / acceptance / performance certificates should be submitted along with the offer.

- The bidder should have successfully executed at least one single order for quantity not less than 2(Two) Nos. for manufacture and supply of similar type of Racks, Steel Fabricated Huts, Crew Cabins, Bunk Houses, Tanks (minimum 100 bbls capacity) during last 05 (five) years preceding the original bid closing date of the tender.
- 2.1 Documentary evidence in respect of the above should be submitted in the form of copy of relevant Purchase Order(s) along with copies of any of the following documents in respect of satisfactory execution of the Purchase Order(s), such as -
- (i) Signed and sealed satisfactory supply / completion report (in original on user's letter head) (OR)
- (ii) Consignee delivery receipt / challan (OR)
- (iii) Central Excise Gate Pass / Tax Invoices issued under relevant rules of Central Excise / VAT/ GST (OR)
- (iv) Any other documentary evidence that can substantiate the satisfactory execution of the purchase order(s) cited above.

Note:

- I. The Purchase Order date need not be within **5** (five) years preceding original bid closing date of this tender. However, the execution of supply should be within 5 (five) years preceding original bid closing date of this tender.
- II. The original bid closing date shall be considered by OIL for evaluation of BRC Criteria in case of any extension of the original bid closing date.
- III. Satisfactory supply / completion / installation report should be issued on company's letterhead with signature and stamp. Originals to be produced for verification on demand of OIL.
- 3. Bidder must forward along with the quotation the detailed drawings along with Bill of material failing which the offer will be liable for rejection.
- 4. The bidder should be a Government registered vendor. Necessary proof in support of the same should be furnished.
- 5. The bidder, if registered as an SSI, should submit the certificate copy of registration with the concerned authorities.
- 6. Delivery: Bidder should categorically confirm in the technical bid for dispatch of the items within six (06) months after receipt of formal order failing which their offer will be rejected.

B) FINANCIAL:

The bidder must have annual Financial Turnover from Operations of at least Rs. 25.33 Lakhs in any of the preceding Three (3) financial/ accounting years

reckoned from the original bid closing date of this tender as per the Audited Annual Reports

[Annual Financial Turnover of the bidder from operations shall mean - "Aggregate value of the realization of amount made from the sale, supply or distribution of goods or on account of services rendered, or both, by the company (bidder) during a financial year" as per the Companies Act, 2013 Section 2 (91).]

b) The Net Worth of the bidder must be positive for the accounting year preceding the original bid closing date.

[Net worth shall mean: "Share capital + Reserves created out of profits a n d securities Premium - Aggregate value of accumulated losses (excluding revaluation reserves) - deferred expenditure - Miscellaneous Expenditure to the extent not written off and carried forward Loss - Reserves created out of write back of depreciation and amalgamation".]

- a) For proof of Annual Turnover & Net worth any one of the following documents must be submitted along with the bid: -

- **b**) In case the bidder is a Central Govt. Organization/PSU/State Govt. Organization/Semi-State Govt. Organization or any other Central/State Govt.
