

CORRIGENDUM No. 1

GeM Tender No.: GEM/2023/B/3091272

This Corrigendum No. 1 dated 27.02.2023 to GeM Tender No. **GEM/2023/B/3091272** for “*Hiring of Upkeepment services on daily basis and other miscellaneous services for ICE-Shop & WSS section, Field Engineering Department, OIL, Duliajan*” is issued to notify the following:

1.0 Bid Closing / Opening dates extended as per following:

(i) Bid Closing Date & Time : Extended up to **07.03.2023 [1400 Hrs (IST)]**

(ii) Bid Opening Date & Time : Extended up to **07.03.2023 [1430 Hrs (IST)]**

2.0 **Annexure-A (copy enclosed)** has been additionally added to the Price Bidding Format. All the bidders are requested to provide their offer in the GeM portal accordingly.

3.0 All others terms and conditions of the Bid Document (including any amendment thereof) remain unchanged. Details can be viewed at www.oil-india.com.

Annexure-A

While quoting, bidders must take into consideration the following:

(A) **Cycle:** As already mentioned in the Scope of Work of the subject tender under Clause A. SCOPE OF WORK 1.0 (Page No. 41 of STC), the Contractor shall be responsible for upkeepment of the ICE Shop & WSS Section of Field Engineering Department by cleaning the ICE Shop and its immediate surroundings daily by providing services on 08 hours per day basis. The area has been divided into 04 (Four) sub-sections and the services are to be provided simultaneously to at least these 04 sub-sections daily. The aforesaid service to be rendered by the Contractor simultaneously to at least 04 sub-sections is considered as **01 (One) cycle**.

(B) **Area (in Sq. metre)** for daily service to be rendered by the Contractor is: 20,000.00 sq metres. This includes the areas of all the 04 (Four) sub-sections.

(C) **Frequency in each Cycle:** 01 (One). This means the Contractor shall provide **services daily once in each cycle**.

(D) **Number of working days in a month :** 25 (Twenty-Five) days

(E) **Contract Duration** = 02 (Two) Years= 24 (Twenty-Four) Months

(F) **Number of cycles during Contract Period :** 600 Cycles (=25 days*24 months)

(G) For the GeM portal, the total quoted price shall be computed as below:

Total Quoted Price (in GeM porta) = Number of Cycles during Contract Period X Area in Sq. Metre X Frequency in each cycle X ***Standard unit rate per Frequency per Cycle***.

In the GeM portal, bidders shall be required to put their '***Standard unit rate per Frequency per Cycle***' considering:

- Number of Cycles during Contract Period as '**600**',
- Area in Sq. Metre as '**20,000.00**' and
- Frequency in each cycle as '**01**'.

Note: In addition to above, bidders shall also have to quote their monthly rate in the Price Bidding Format (Ref: Price bidding Format of the tender). However, the total value quoted in the Price Bidding Format and the total Value computed as mentioned-above in the GeM portal must match with one another. In case of any mismatch in the price quoted by the bidder in the Price bidding Format and in the price computed in the GeM portal, the price mentioned in the GeM portal shall be considered and shall prevail i.e. the ranking of the bidders (L1, L2...) shall be based upon the offer provided by the bidders against the subject tender in the GeM portal.
