- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. Bidders can also submit the EMD with Payment online through RTGS / internet banking in Beneficiary name Oil India Limited

Bidder to indicate bid number and name of bidding entity in the transaction details field at the time of online transfer. Bidder has to upload scanned copy / proof of the Online Payment Transfer along with bid.

- 3. Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

The alternator terminal box should be suitable and should have sufficient space for terminating 4 core X 50 sq.mm, 1100V grade PVC insulated stranded copper cable. Separate cable box shall be provided for supporting power cable. Suitable size of cable gland should be fitted in the terminal box. Cable gland and entry hole shall also be required for AVR cables as AVR shall be mounted in the control panel.

The alternator terminal box should be suitable and should have sufficient space for terminating 4 core X 50 sq.mm, 110 0V grade PVC insulated stranded copper cable. Suitable metallic cable tray/c able conduit shall be provided for mechanical support and protection of power cable. Suitable size of cable gland should be fitted in the terminal box. Cable gland and entry hole shall also be required for AVR cable as AVR shall be mounted in the control panel.

- 1.2 In case, the Bid Security in the form of a Bank Guarantee is found to be not genuine or issued by a fak e banker or issued under the fake signatures, the bid submitted by the concerned bidder shall be rej ected and the bidder shall be banned from participating in future tenders in accordance with the pro visions of Company's Banning Policy, 2017. Further, the Bid Security submitted by such bidder shall be invoked without any further reference, besides other penal action, as the Company may think app ropriate.
- 1.3 The Bid Security of the unsuccessful bidders will be returned after finalization of tender whereas the B id Security of the successful bidder will be discharged on such bidder's furnishing the Performance S ecurity to OIL against the Purchase Order secured by the bidder within the stipulated time frame. The successful bidder will however, extend validity of the Bid Security till such time the Performance Se curity is furnished.

1.0 APPLICABILITY OF BANNING POLICY OF OIL INDIA LIMITED:

Banning Policy dated 6th January, 2017 as uploaded in OIL's website and revised guidelines of banning/deb arment vide OM no. F.1/20/2018-PPD dated 02.11.2021 issued by Department of Expenditure, Ministry of Fi nance, Govt ofIndia will be applicable against the tender (and order in case of award) to deal with any agen cy (bidder/contractor/supplier/ vendor /service provider) who commits deception, default, fraud or indulged in other misconduct of

whatsoever nature in the tendering process and/or order execution processes. The bidders who are on Holi day/Banning/Suspension list of OIL on due date of submission of bid/during the process of evaluation of the bids, the offers of such bidders shall not be considered for bid opening/evaluation/award. (Invoice Mart). MSE vendors can avail this benefit by registering themselves with any of the exchanges providing e-discounting / electronic factoring services on TReDS platform and following the procedures defined therein, provided OIL is also participating in such TReDS Platform as a Buyer.

- (i) MSE Vendor should be aware that all costs relating to availing the facility of discounting on TReDS platfor m including but not limited to Registration charges, Transaction charges for financing, Discounting Charges, Interest on financing, or any other charges known by any name shall be borne by MSE Vendor.
- (ii) MSE Vendor hereby agrees to indemnify, hold harmless and keep OIL and its

affiliates, Directors, officers, representatives, agents and employees indemnified, from any and all damages , losses, claims and liabilities (including legal costs) which may arise from Sellers submission, posting or dis play, participation, in any manner, on the TReDS Platform or from the use of Services or from the Buyer's br each of any of the terms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity basis.

(iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any da mages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from usin g TReDS platform for discounting their (MSE Vendor's) invoices.

- (ii) Seller means a MSE vendor, who has been awarded Purchase Order/Contract by OIL (Buyer).

4.0 **SET-OFF**: Any sum of money due and payable to the contractor (including Security Deposit refundable to them) under this or any other contract may be appropriated by Oil India Limited and set-off against any claim of Oil India Limited (or such other person or persons contracting through Oil India Limited) for paymen t of a sum of money arising out of this contract or under any other contract made by the contractor with Oil India Limited (or such other person or persons contracting through Oil India Limited).

- 5.0 The tender has been floated in GeM portal under **Single Stage Two Bid System.** Therefore, bidder m ust not disclose their prices in their technical offer. The technical bid shall contain all techno-commercial de tails except the prices/costs. Bidder must note that disclosure of price in technical bids shall lead to rejection of the offer.
- 6.0. The bidders must submit the duly filled up Annexure-B (Evaluation Matrix for Technical Specification), u ploaded as Buyer Added Bid Specific ATC
- 7.0 The bidders must ensure that no part of the price bid is mentioned /uploaded along with the technical d ocuments. The price bids must be provided in the inbuilt price schedules only. In case any of the bidders up loads any price bids along with the technical documents, their offers shall be summarily rejected.
- 8.0 The bidders must include the prices for all items including Spares, Mandatory Engine spares and engine control panel spares.
- 5. The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. The goods for which bids have been invited fall under classification of GST concession and the conditions for eligibility of concession are met by the institution. A certificate to this effect will be issued by Buyer to the Seller after award of the Contract. Sellers are requested to submit their bids after accounting for the Concessional rate of GST.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
