This Corrigendum is issued to notify the following changes:

**1.0 To add the following Clauses, under Clause No. 5.0, of STC, SETCION-II, SCC:**

**QUOTE:**

*xi. Dead Weight to be arranged by the contractor for testing / Inspection / repairing.*

*xii. Transportation of Manpower to be arranged by the contractor.*

**xiii. MAINTENANCE OF HOT CRANE:**

- a. Under this contract the contractor shall provide planned maintenance service to keep the HOT Cranes in good working condition.*
- b. All the spares parts and consumables required to keep the equipment in good working Condition, shall be under the scope of the Contractor during the entire Contract period, including extension if any.*
- c. For planned maintenance service the contractor shall make visits on mutually convenient date.*
- d. During the Contract period, the contractor shall undertake breakdown maintenance service, as and when intimated by HoD-Logistics or his authorised Engineer In-charge through E-mail / telephone.*

**5.1 Penalty:**

- a. The Contractor shall have to attend any breakdown calls within 24 (twenty-four) hours from intimation from Logistics Department, via telephone / E-mail. In case the breakdown is not attended within this period a Penalty of Rs. 10,000.00/per day [limiting to 7.5% of the contract value] will be deducted from the running invoice/SES.*
- b. In case the contractor fails to attend the breakdown call, even after crossing*

penalty of Rs. 7.5% of the contract value, the contract shall be liable for termination.
