This Corrigendum dated 21.09.2023 to Tender No. GEM/2023/B/3711842 – “Hiring of services for Conversion

on and Migration (as the case may be) of SAP landscape from on-premise ECC6.0 to Private Cloud Edition on RISE across OIL” is issued to notify the following:

1.0 Clause No. 14.0 of Part-A of SCC stands amended as below:

Quote:

OEM Services: OEM service of 1500 man-days have been kept as per Clause No. 2.6.9 of SOW in the scope of the contractor. In case of requirement of additional OEM hours beyond 1500 Persons Day/M an Days, no additional payment will be made from OIL's end, and it will be exclusively borne by the contractor. Prior approval from OIL's ERP department will be mandatory for utilization of OEM man-d ays. Payment towards OEM services will be as per actual. Out of the estimated quantity of 1500 Man days, 80% deployment should be onsite in Duliajan while the remainder may be utilised for 'Off-Site' deployment. Bidders to take note of the same while quoting their rates. One 'Manday' is defined as eight-hour engagement of an OEM Expert.

Note:

(i) Any services that are delivered from any SAP-office location (remote) decided by SAP which is oth er than the location specified in the agreement is considered as Off-site/ Remote.

(ii) OIL's ERP department will maintain a comprehensive cumulative chart during the contract execu tion to track the allocation of onsite and offsite mandays. The required distribution of 80% onsite an d 20% offsite deployment of OEM Service will be an essential criterion for approving OEM Mandays t o the implementing partner.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
